## LEGISLATIVE COUNSEL'S DIGEST

SB 268, as amended, Nguyen. Income taxes: credit: dependent care. The Personal Income Tax Law, in modified conformity to federal income tax law, authorizes a credit for household and dependent care expenses necessary for gainful employment, as provided. The amount of the credit is a percentage of the allowable federal credit determined on the basis of the amount of federal adjusted gross income, up to \$100,000.

This bill, for taxable years beginning on or after January 1, 2015, would increase that amount of federal adjusted gross income, up to \$250,000, and would increase the amount of employment-related expenses incurred during a taxable year which may be taken into account in determining the amount of the credit from \$3,000 to \$4,000 if there is one qualifying dependent and from \$6,000 to \$12,000 if there are 2 or more qualifying dependents.

This bill would take effect immediately as a tax levy.

The Personal Income Tax Law, in modified conformity to federal income tax law, authorizes a credit for household and dependent care expenses necessary for gainful employment, as provided.

This bill, for taxable years beginning on or after January 1, 2015, would increase the amount of employment-related expenses incurred during a taxable year which may be taken into account in determining the amount of the credit from \$3,000 to \$4,000 if there is one qualifying dependent and from \$6,000 to \$12,000 if there are 2 or more qualifying dependents.

This bill would take effect immediately as a tax levy.

17052.6. (a) For each taxable year beginning on or after January 1, 2000, there shall be allowed as a credit against the "net tax", as defined in Section 17039, an amount determined in accordance with Section 21 of the Internal Revenue Code, relating to expenses for household and dependent care services necessary for gainful employment, except that the amount of the credit shall be a percentage, as provided in subdivision (b) of the allowable federal credit without taking into account whether there is a federal tax liability.

- (b) For the purposes of subdivision (a), the percentage of the allowable federal credit shall be determined as follows:

- (c) For purposes of this section, "adjusted gross income" means adjusted gross income as computed for purposes of paragraph (2) of subdivision (h) of Section 17024.5.
- (d) The credit authorized by this section shall be limited, as follows:
- (1) Employment-related expenses, within the meaning of Section 21 of the Internal Revenue Code, relating to expenses for household and dependent care services necessary for gainful employment, shall be limited to expenses for household services and care provided in this state.
- (2) Earned income, within the meaning of Section 21(d) of the Internal Revenue Code, *relating to earned income limitation*, shall be limited to earned income subject to tax under this part. For purposes of this paragraph, compensation received by a member of the armed forces for active services as a member of the armed forces, other than pensions or retired pay, shall be considered earned income subject to tax under this part, whether or not the member is domiciled in this state.
- (e) For purposes of this section, Section 21(b)(1) of the Internal Revenue Code, relating to a qualifying individual, is modified to additionally provide that a child, as defined in Section 151(c)(3) 152(c)(3) of the Internal Revenue Code, relating to age requirements, shall be treated, for purposes of Section 152 of the Internal Revenue Code, relating to dependent defined, as applicable
