An act to ~~amend, repeal, and add~~ *amend* Section 596.5 of the Penal Code, relating to animal cruelty.

LEGISLATIVE COUNSEL'S DIGEST

SB 716, as amended, Lara. Animal cruelty: elephants.

Existing law makes it a misdemeanor for any owner or manager of an elephant to engage in abusive behavior toward the elephant, which includes disciplining an elephant by specified methods, including, but not limited to, use of electricity.

This bill would, beginning January 1, 2018, additionally provide that abusive behavior toward the elephant includes ~~the discipline, management, or training of the elephant by specified methods, including the use of a bullhook, ankus, guide, or pitchfork.~~ *baseball bat, axe handle, pitchfork, or similar device by any person who houses, possesses, or is in direct contact with an elephant.* By expanding the scope of a crime, the bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

17 *(b) On or after January 1, 2018, it shall be a misdemeanor for*
18 *any person who houses, possesses, or is in direct contact with an*
19 *elephant to use a bullhook, ankus, baseball bat, axe handle,*
20 *pitchfork, or similar device designed to inflict pain for the purpose*
21 *of training or controlling the behavior of an elephant. Use*
22 *prohibited by this section includes brandishing, exhibiting, or*
23 *displaying such devices in the presence of an elephant.*

2 *SEC. 2.* No reimbursement is required by this act pursuant to
3 Section 6 of Article XIII B of the California Constitution because
4 the only costs that may be incurred by a local agency or school
5 district will be incurred because this act creates a new crime or
6 infraction, eliminates a crime or infraction, or changes the penalty
7 for a crime or infraction, within the meaning of Section 17556 of
8 the Government Code, or changes the definition of a crime within
9 the meaning of Section 6 of Article XIII B of the California
10 Constitution.
