An act to amend Sections 79831 and 79835 of the Food and Agricultural Code, relating to olive oil.

LEGISLATIVE COUNSEL'S DIGEST

SB 746, as amended, Wolk. Olive Oil Commission of California: *voting members*: chair of advisory committee.

Existing law *establishes the Olive Oil Commission of California and provides for the establishment of an advisory committee to advise the board of directors of the Olive Oil Commission of California, as specified, and provides that the chair of the advisory committee shall be an ex officio member of the commission board of directors. of the commission comprised of 10 voting members, as specified. Existing law further provides for an advisory committee to advise the commission board of directors, provides for the selection of the chair of the advisory committee by the members of the commission, and specifies that the chair of the advisory committee shall be a nonvoting member of the commission board of directors.*

This bill would instead ~~require~~ *establish* the chair of the advisory committee to be a member, rather than ~~an ex officio~~ *a nonvoting* member, of the commission board of directors. The bill would also require the chair of the advisory committee to designate an alternate advisory committee member to serve in the chair's absence.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 79831 of the Food and Agricultural Code  
2 is amended to read:  
3 79831. (a) There is in the state government the Olive Oil  
4 Commission of California. Except as provided in subdivision ~~(d)~~;  
5 (c), the commission board of directors shall be composed of the  
6 following:  
7 (1) Six producers, two from each district.  
8 (2) Three handlers, one from each district.  
9 (3) One public member who shall be appointed to the  
10 commission board of directors by the secretary from nominees  
11 recommended by the commission board of directors.

13 (4) The chair of the advisory committee described in subdivision  
14 ~~(e)~~ shall be a member of the commission board of directors.

17 (b) The secretary and other appropriate persons as determined

20 (c) The commission board of directors may modify the number

23 if proper notice is provided to all persons subject to this chapter

26 (d) An advisory committee shall meet periodically to review  
27 issues affecting the purposes of this chapter and shall advise the  
28 commission board of directors. The advisory committee shall  
29 consist of seven members who shall each serve three-year terms.

32 SEC. 2. Section 79835 of the Food and Agricultural Code is

34 79835. (a) Except for the ex officio members of the  
35 commission board of directors, each member of the commission

1 board of directors shall have an alternate member elected in the  
2 same manner as the member. An alternate member, in the absence  
3 of the member for whom he or she is an alternate, shall serve in  
4 place of the member. An alternate member may also serve in place  
5 of any other absent member of the same classification, producer  
6 or handler, if the member's alternate is also absent. However, an  
7 alternate member may not serve in place of more than one absent  
8 member at a meeting. An alternate member serving in place of a  
9 member shall have and be able to exercise all rights, privileges,  
10 and powers of the member when serving. In the event of death,  
11 removal, resignation, or the disqualification of a member, the  
12 alternate for the member, or another alternate of the same  
13 classification if the alternate member for the member is absent,  
14 shall act as the member until a qualified successor is elected.

15 (b) The chair of the advisory committee shall designate a  
16 member of the advisory committee to serve as an alternate in place  
17 of the chair in the chair's absence. An alternate advisory committee  
18 member serving in the place of the chair shall have and be able to  
19 exercise all rights, privileges, and powers of the chair when serving.
