LEGISLATIVE COUNSEL'S DIGEST

SB 1223, as amended, Huff. ~~Provisional driver's licenses. Driver's licenses: provisional licenses.~~

Existing law, the Brady-Jared Teen Driver Safety Act of 1997, establishes a provisional licensing program and generally requires that a driver's license issued to a person at least 16 years of age but under 18 years of age be issued pursuant to that provisional licensing program. During the first 12 months after issuance of a provisional license, existing law prohibits the licensee from driving between the hours of 11 p.m. and 5 a.m. and transporting passengers who are under 20 years of age, unless he or she is accompanied and supervised by a licensed driver, as specified, or a licensed or certified driving instructor. Existing law provides limited exceptions to these restrictions under which a licensee is authorized to drive under specified circumstances, including a schooling or school-authorized activity or an employment necessity, and requires the licensee to keep certain supporting documentation in his or her possession. A violation of these provisions is punishable as an infraction.

This bill would expand the scope of the provisional licensing program by extending the applicable age range for the program from 16 to under 18 years of age to 16 to under 21 years of age. By expanding the scope

of the provisional licensing program, the violation of which constitutes an infraction, the bill would impose a state-mandated local program. The bill would authorize a licensee who is 18, 19, or 20 years of age to keep in his or her possession a copy of his or her class schedule or work schedule as documentation to satisfy the exceptions for schooling or school-authorized activity and employment necessity, respectively, and would provide that a signed statement by a parent or legal guardian is not required if reasonable transportation facilities are inadequate and the operation of a vehicle by a licensee who is 18, 19, or 20 years of age is necessary to transport the licensee or the licensee's immediate family member. The bill would make other conforming changes.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

~~Existing law, the Brady-Jared Teen Driver Safety Act of 1997, permits a person who is at least 16 years of age, but under 18 years of age, to apply for and be issued a provisional driver's license. The act requires licensees to comply with certain requirements, including completing specified driver education and training, and imposes certain driving restrictions on licensees, including, among other restrictions, prohibiting licensees, during the first 12 months after issuance of the provisional license, from driving during the hours between 11 p.m. and 5 a.m., or transporting passengers who are under 20 years of age, except as specified. A violation of these driving restrictions is a crime.~~

~~Existing law makes it an infraction punishable by a base fine of \$20 for a first offense and \$50 for each subsequent offense for a person under 18 years of age to drive a motor vehicle while using a wireless telephone or an electronic wireless communication device, as specified.~~

~~This bill would require that the provisional driver's license and the accompanying restrictions imposed upon that license remain in effect until the driver reaches 18 years of age, if a minor who holds the provisional license is convicted of driving a motor vehicle while using a wireless telephone or an electronic wireless communication device, as specified. The people of the State of California do enact as follows:

3 12814.6. (a) Except as provided in Section 12814.7, a driver's
4 license issued to a person at least 16 years of age but under 18 21
5 years of age shall be issued pursuant to the provisional licensing
6 program contained in this section. The program shall consist of
7 all of the following components:

8 (1) Upon application for an original license, the applicant shall
9 be issued an instruction permit pursuant to Section 12509. A person
10 who has in his or her immediate possession a valid permit issued
11 pursuant to Section 12509 may operate a motor vehicle, other than
12 a motorcycle or motorized bicycle, only when the person is either
13 taking the driver training instruction referred to in paragraph (3)
14 or practicing that instruction, provided the person is accompanied
15 by, and is under the immediate supervision of, a California licensed
16 driver 25 years of age or older whose driving privilege is not on
17 probation. The age requirement of this paragraph does not apply
18 if the licensed driver is the parent, spouse, or guardian of the
19 permitholder or is a licensed or certified driving instructor.

20 (2) The person shall hold an instruction permit for not less than
21 six months prior to applying for a provisional driver's license.

22 (3) The person shall have complied with one of the following:

23 (A) Satisfactory completion of approved courses in automobile
24 driver education and driver training maintained pursuant to
25 provisions of the Education Code in any secondary school of
26 California, or equivalent instruction in a secondary school of
27 another state.

28 (B) Satisfactory completion of an integrated driver education
29 and training program that is approved by the department and
30 conducted by a driving instructor licensed under Chapter 1

1 (commencing with Section 11100) of Division 5. The program
2 shall utilize segmented modules, whereby a portion of the
3 educational instruction is provided by, and then reinforced through,
4 specific behind-the-wheel training before moving to the next phase
5 of driver education and training. The program shall contain a
6 minimum of 30 hours of classroom instruction and six hours of
7 behind-the-wheel training.

8 (C) Satisfactory completion of six hours or more of
9 behind-the-wheel instruction by a driving school or an independent
10 driving instructor licensed under Chapter 1 (commencing with
11 Section 11100) of Division 5 and either an accredited course in
12 automobile driver education in any secondary school of California
13 pursuant to provisions of the Education Code or satisfactory
14 completion of equivalent professional instruction acceptable to
15 the department. To be acceptable to the department, the
16 professional instruction shall meet minimum standards to be
17 prescribed by the department, and the standards shall be at least
18 equal to the requirements for driver education and driver training
19 contained in the rules and regulations adopted by the State Board
20 of Education pursuant to the Education Code. A person who has

27 (4) The person shall complete 50 hours of supervised driving

31 during darkness, as defined in Section 280. Upon application for
32 a provisional license, the person shall submit to the department
33 the certification of a parent, spouse, guardian, or licensed or

(5) The person shall successfully complete an examination required by the department. Before retaking a test, the person shall wait for not less than one week after failure of the written test and for not less than two weeks after failure of the driving test.

(b) Except as provided in Section 12814.7, the provisional driver's license shall be subject to all of the following restrictions:

(1) Except as specified in paragraph (2), during the first 12 months after issuance of a provisional license the licensee ~~may~~ *shall* not do any of the following unless accompanied and supervised by a licensed driver who is the licensee's parent or guardian, a licensed driver who is 25 years of age or older, or a licensed or certified driving instructor:

(A) Drive between the hours of 11 p.m. and 5 a.m.

(B) Transport passengers who are under 20 years of age.

(2) A licensee may drive between the hours of 11 p.m. and 5 a.m. or transport an immediate family member without being accompanied and supervised by a licensed driver who is the licensee's parent or guardian, a licensed driver who is 25 years of age or older, or a licensed or certified driving instructor, in the following circumstances:

(A) Medical necessity of the licensee when reasonable transportation facilities are inadequate and operation of a vehicle by a ~~minor~~ licensee is necessary. The licensee shall keep in his or her possession a signed statement from a physician familiar with the condition, containing a diagnosis and probable date when sufficient recovery will have been made to terminate the necessity.

(B) Schooling or school-authorized activities of the licensee when reasonable transportation facilities are inadequate and operation of a vehicle by a licensee is necessary.

22 notification issued pursuant to Section 40509 or 40509.5 has been
23 cleared.

24 (2) A 30-day restriction shall be imposed when a driver's record
25 shows a violation point count of two or more points in 12 months,
26 as determined in accordance with Section 12810. The restriction
27 shall require the licensee to be accompanied by a licensed parent,
28 spouse, guardian, or other licensed driver 25 years of age or older,
29 except when operating a class M vehicle, or so licensed, with no
30 passengers aboard.

31 (3) A six-month suspension of the driving privilege and a
32 one-year term of probation shall be imposed whenever a licensee's
33 record shows a violation point count of three or more points in 12
34 months, as determined in accordance with Section 12810. The
35 terms and conditions of probation shall include, but not be limited
36 to, both of the following:

(h) Whenever action by the department under subdivision (g) arises as a result of a motor vehicle accident, the person may, in writing and within 10 days, demand a hearing to present evidence that he or she was not responsible for the accident upon which the action is based. Whenever action by the department is based upon a conviction reportable to the department under Section 1803, the person has no right to a hearing pursuant to Article 3 (commencing with Section 14100) of Chapter 3.

(i) The department shall require a person whose driving privilege is suspended or revoked pursuant to subdivision (g) to submit proof of financial responsibility as defined in Section 16430. The proof of financial responsibility shall be filed on or before the date of reinstatement following the suspension or revocation. The proof of financial responsibility shall be maintained with the department for three years following the date of reinstatement.

(j) (1) Notwithstanding any other provision of this code, the department may issue a distinctive driver's license, that displays a distinctive color or a distinctively colored stripe or other distinguishing characteristic, to persons at least 16 years of age and older but under 18 years of age, and to persons 18 years of age and older but under 21 years of age, so that the distinctive license feature is immediately recognizable. The features shall clearly differentiate between driver's licenses issued to persons at least 16 years of age or older but under 18 years of age and to persons 18 years of age or older but under 21 years of age.

(2) If changes in the format or appearance of driver's licenses are adopted pursuant to this subdivision, those changes may be implemented under any new contract for the production of driver's licenses entered into after the adoption of those changes.

(k) The department shall include, on the face of the provisional driver's license, the original issuance date of the provisional driver's license in addition to any other issuance date.

(l) This section shall be known and may be cited as the Brady-Jared Teen Driver Safety Act of 1997.
