SENATE BILL

An act to add Section 14132.19 to the Welfare and Institutions Code, relating to Medi-Cal.

LEGISLATIVE COUNSEL'S DIGEST

SB 1466, as amended, Mitchell. Early and Periodic Screening, Diagnosis, and Treatment Program: trauma screening.

Existing law provides for the Medi-Cal program, which is administered by the State Department of Health Care Services, under which qualified low-income individuals receive health care services, including early and periodic screening, diagnosis, and treatment for any individual under 21 years of age who is covered under Medi-Cal consistent with the requirements under federal law. The Medi-Cal program is, in part, governed and funded by federal Medicaid Program provisions.

Existing federal law provides that EPSDT services include periodic screening services, vision services, dental services, hearing services, and other necessary services to correct or ameliorate defects and physical and mental illnesses and conditions discovered by the screening services, whether or not the services are covered under the state plan. In addition to the required periodic screening services, existing federal law provides that Medicaid-eligible children are entitled to interperiodic screenings

in order to ~~identity~~ *identify* a suspected illness or condition not present or discovered during the periodic ~~exam~~: *examination*.

The bill would require, consistent with federal law, those screening services under the EPSDT program to include screening for trauma, as defined by the bill. ~~The bill would require that a child who is found to have experienced trauma through the screening process be referred to the county mental health plan for an assessment for specialty mental health services. The bill would require that any child who is found to have experienced trauma during a screening made pursuant to these provisions, and any child that is abused, neglected or removed from the custody or care of his or her parent or legal guardian, as specified, be assessed by the county mental health plan for specialty mental health services. The bill would require that a child who is determined not to be eligible for specialty mental health services be referred for other necessary health care, diagnostic services, treatment, and other measures, as specified.~~

8 physiological response to an event, series of events, or set of
9 circumstances that is experienced by an individual as physically
10 or emotionally harmful or life threatening and that has lasting
11 adverse effects on the individual’s functional and mental, physical,
12 social, emotional, or spiritual well-being.
