

Assembly Bill No. 849

CHAPTER 92

An act to make an appropriation in augmentation of Items 9840-001-001, 9840-001-494, 9840-001-988, and 9840-011-001 of Section 2.00 of the Budget Act of 1994, relating to contingencies or emergencies, to take effect immediately as an appropriation for the usual current expenses of the state.

LEGISLATIVE COUNSEL'S DIGEST

AB 849, Vasconcellos. Budget Act of 1994: contingencies or emergencies.

(1) The Budget Act of 1994 appropriated \$4,500,000 in equal amounts from the General Fund, unallocated special funds, and unallocated nongovernmental cost funds for expenditure for contingencies or emergencies upon written authorization from the Director of Finance.

This bill would appropriate \$212,326,000, as scheduled, in augmentation of these Budget Act appropriations.

This bill would authorize the Director of Finance to withhold authorization for the expenditure of funds appropriated in the bill until preliminary estimates of potential deficiencies are verified.

(2) This bill would declare that it is to take effect immediately as a statute providing an appropriation for the usual current expenses of the state.

Appropriation: yes.

The people of the State of California do enact as follows:

SECTION 1. (a) The sum of two hundred twelve million three hundred twenty-six thousand dollars (\$212,326,000) is hereby appropriated for expenditure in the 1994-95 fiscal year in augmentation of, and for the purposes of, contingencies or emergencies as provided in Items 9840-001-001, 9840-001-494, 9840-001-988, and 9840-011-001 of Section 2.00 of the Budget Act of 1994 (Ch. 139, Stats. 1994), in accordance with the following schedule:

(1) One hundred eighty-one million seven hundred ninety-seven thousand dollars (\$181,797,000) from the General Fund to the Reserve for Contingencies or Emergencies in Item 9840-001-001.

(2) Two million four hundred forty-seven thousand dollars (\$2,447,000) from the General Fund to the Reserve for Contingencies or Emergencies (Loans) in Item 9840-011-001.

(3) Nineteen million eight hundred forty-two thousand dollars (\$19,842,000) from unallocated special funds to the Reserve for Contingencies or Emergencies in Item 9840-001-494.

(4) Eight million two hundred forty thousand dollars (\$8,240,000) from unallocated nongovernmental cost funds to the Reserve for Contingencies or Emergencies in Item 9840-001-988.

(b) The Director of Finance may withhold authorization for the expenditure of funds provided in this section until such time as, and to the extent that, preliminary estimates of potential deficiencies are verified.

SEC. 2. This act makes an appropriation for the usual current expenses of the state within the meaning of Article IV of the Constitution and shall go into immediate effect.
