Senate Concurrent Resolution No. 22—Relative to the State Highway Route 156 Hollister Bypass Project.

LEGISLATIVE COUNSEL'S DIGEST

SCR 22, as amended, McPherson. State Highway Route 156 Hollister Bypass Project: designation.

This measure would designate the State Highway Route 156 Hollister Bypass Bridge crossing the San Benito River the Ed Hanna Memorial Bridge and would designate the bypass itself the Veterans Memorial Highway. The Department of Transportation would be requested to determine the cost of

appropriate plaques and markers showing these special designations and, upon receiving donations from nonstate sources sufficient to cover that cost, to erect appropriate plaques and markers.

Fiscal committee: yes.

1 WHEREAS, The State Highway Route 156 Hollister
2 Bypass is nearing completion; and

3 WHEREAS, The bypass will include construction of a
4 new bridge crossing the San Benito River which is to be
5 designated 43-44; and

6 WHEREAS, Ed Hanna was a longtime county
7 employee, having worked in the 1940's as the county
8 surveyor and also worked as the county engineer and
9 road commissioner; and

10 WHEREAS, Ed Hanna was a respected member of the
11 County Engineers Association; and

12 WHEREAS, It is appropriate that the new bridge
13 crossing the San Benito River be dedicated to the
14 memory of Ed Hanna, and that the bypass be named in
15 honor of military veterans; now, therefore, be it

16 *Resolved by the Senate of the State of California, the*
17 *Assembly thereof concurring,* That the bridge designated
18 43-44 on the State Highway Route 156 Hollister Bypass is
19 hereby officially designated the Ed Hanna Memorial
20 Bridge, and that the State Highway Route 156 Hollister
21 Bypass is hereby officially designated the Veterans
22 Memorial Highway; and be it further

23 *Resolved,* That the Department of Transportation is
24 requested to determine the cost of appropriate plaques
25 and markers, consistent with the signing requirements of
26 the state highway system, showing these special
27 designations and, upon receiving donations from
28 nonstate sources sufficient to cover that cost, to erect
29 appropriate plaques and markers showing these special
30 designations; and be it further

31 *Resolved,* That the Secretary of the Senate transmit a
32 copy of this resolution to the Director of Transportation.
