SENATE BILL

No. 143

Introduced by Senator Kopp

January 13, 1997

An act to amend Sections 6252 and 6258 of, to amend and renumber Section 6253 of, to add Sections 6252.5 and 6253 to, to add a heading as Article 1 (commencing with Section 6250) to Chapter 3.5 of, to add Article 2 (commencing with Section 6275) to Chapter 3.5 of, Division 7 of Title 1 of, and to repeal Sections 6253.1, 6256, 6256.1, 6256.2, and 6257 of, the Government Code, relating to records.

LEGISLATIVE COUNSEL'S DIGEST

SB 143, as amended, Kopp. Records.

(1) Existing provisions of the California Public Records Act require each state and local agency, as defined, to make its records open to public inspection at all times during office hours, except as specifically exempted from disclosure by law. The act also defines the terms "writing," "person," and "member of the public."

This bill would revise the definitions of local agency and "writing" and would define "public agency." The bill would

also provide for public inspection of public records and copying in all forms, as specified. The bill would further require public agencies to ensure that systems used to collect and hold public records be designed to ensure ease of public access.

This bill would expressly state that notwithstanding the definition of “member of the public,” an elected member or officer of any state or local agency is entitled to access to public records of that agency on the same basis as any other person and would state that it is declaratory of existing law.

This bill would incorporate changes made to the California Public Records Act by the Governor’s Reorganization Plan of 1991, including adding the Department of Toxic Substances Control and the Office of Environmental Health Hazard Assessment to the list of state and local bodies that are required to establish written guidelines for accessibility of records.

(2) Existing law provides that the California Public Records Act shall not be construed to require disclosure of records, the disclosure of which is exempted or prohibited by provisions of federal or state law.

This bill would list specific provisions of law coming within that exemption.

By requiring a higher level of service of local agencies in administering the California Public Records Act, this bill would impose a state-mandated local program.

(3) Under the act, any person is authorized to institute proceedings for injunctive or declaratory relief or writ of mandate to enforce that person’s right to inspect or to receive a copy of any public record or class of public records.

This bill would limit this authorization to apply for judicial relief under the act to persons who submitted a written request for a public record and that request was denied.

(4) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement, including the creation of a State Mandates Claims Fund to pay the costs of mandates which do not exceed \$1,000,000 statewide and other



procedures for claims whose statewide costs exceed \$1,000,000.

This bill would provide that, if the Commission on State Mandates determines that this bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to those statutory procedures and, if the statewide cost does not exceed \$1,000,000, shall be made from the State Mandates Claims Fund.

10 (a) “State agency” means every state office, officer,
11 department, division, bureau, board, and commission or
12 other state body or agency, except those agencies
13 provided for in Article IV (except Section 20 thereof) or
14 Article VI of the California Constitution.

15 (b) “Local agency” includes a county; city, whether
16 general law or chartered; city and county; school district;
17 municipal corporation; district; political subdivision; or
18 any board, commission or agency thereof; other local
19 public agency; or nonprofit organizations or entities that
20 are legislative bodies of a local agency pursuant to
21 subdivisions (c) and (d) of Section 54952.

22 (c) “Person” includes any natural person, corporation,
23 partnership, limited liability company, firm, or
24 association.

25 (d) “Public agency” means any state or local agency.

26 (e) “Public records” includes any writing containing
27 information relating to the conduct of the public’s

1 business prepared, owned, used, or retained by any state
2 or local agency regardless of physical form or
3 characteristics. “Public records” in the custody of, or
4 maintained by, the Governor’s office means any writing
5 prepared on or after January 6, 1975.

6 (f) “Writing” means handwriting, typewriting,
7 printing, photostating, photographing, and every other
8 means of recording upon any form of communication or
9 representation, including letters, words, pictures, sounds,
10 or symbols, or combination thereof, and all papers, maps,
11 magnetic or paper tapes, photographic films and prints,
12 magnetic or punched cards, discs, drums, and other
13 documents.

14 (g) “Member of the public” means any person, except
15 a member, agent, officer, or employee of a federal, state,
16 or local agency acting within the scope of his or her
17 membership, agency, office, or employment.

18 SEC. 3. Section 6252.5 is added to the Government
19 Code, to read:

20 6252.5. Notwithstanding the definition of “member of
21 the public” in Section 6252, an elected member or officer
22 of any state or local agency is entitled to access to public
23 records of that agency on the same basis as any other
24 person. Nothing in this section shall limit the ability of
25 elected members or officers to access public records
26 permitted by law in the administration of their duties.

27 This section does not constitute a change in, but is
28 declaratory of, existing law.

29 SEC. 4. Section 6253 of the Government Code is
30 amended and renumbered to read:

31 6253.4. (a) Every agency may adopt regulations
32 stating the procedures to be followed when making its
33 records available in accordance with this section.

34 The following state and local bodies shall establish
35 written guidelines for accessibility of records. A copy of
36 these guidelines shall be posted in a conspicuous public
37 place at the offices of these bodies, and a copy of the
38 guidelines shall be available upon request free of charge
39 to any person requesting that body’s records:

6 SEC. 5. Section 6253 is added to the Government
7 Code, to read:

8 6253. (a) Public records are open to inspection at all
9 times during the office hours of the state or local agency
10 and every person has a right to inspect any public record,
11 except as hereafter provided. Any reasonably segregable
12 portion of a record shall be available for inspection by any
13 person requesting the record after deletion of the
14 portions that are exempted by law.

15 (b) Except with respect to public records exempt
16 from disclosure by express provisions of law, each state or
17 local agency, upon a request for a copy of records that
18 reasonably describes an identifiable record or records,
19 shall make the records promptly available to any person,
20 upon payment of fees covering direct costs of duplication,
21 or a statutory fee, if applicable. Upon request, an exact
22 copy shall be provided unless impracticable to do so.
23 Computer data shall be provided in a form determined
24 by the agency.

25 (c) Each agency, upon a request for a copy of records
26 shall, within 10 days from receipt of the request,
27 determine whether the request, in whole or in part, seeks
28 copies of disclosable public records in the possession of
29 the agency and shall promptly notify the person making
30 the request of the determination and the reasons
31 therefor. In unusual circumstances, the time limit
32 prescribed in this section may be extended by written
33 notice by the head of the agency or his or her designee to
34 the person making the request setting forth the reasons
35 for the extension and the date on which a determination
36 is expected to be dispatched. No notice shall specify a date
37 that would result in an extension for more than 14 days.
38 As used in this section, “unusual circumstances” means,
39 but only to the extent reasonably necessary to the proper
40 processing of the particular request:



(1) The need to search for and collect the requested records from field facilities or other establishments that are separate from the office processing the request.

(2) The need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records which are demanded in a single request.

(3) The need for consultation, which shall be conducted with all practicable speed, with another agency having substantial interest in the determination of the request or among two or more components of the agency having substantial subject matter interest therein.

(d) Nothing in this chapter shall be construed to permit an agency to obstruct the inspection or copying of public records. Any notification of denial of any request for records shall set forth the names and titles or positions of each person responsible for the denial.

(e) Except as otherwise prohibited by law, a state or local agency may adopt requirements for itself that allow for faster, more efficient, or greater access to records than prescribed by the minimum standards set forth in this chapter.

1 inspect or to receive a copy of that public record or class
2 of public records under this chapter. The times for
3 responsive pleadings and for hearings in these
4 proceedings shall be set by the judge of the court with the
5 object of securing a decision as to these matters at the
6 earliest possible time.

7 SEC. 12. Article 2 (commencing with Section 6275) is
8 added to Chapter 3.5 of Division 7 of Title 1 of the
9 Government Code, to read:

11 Article 2. Other Exemptions from Disclosure

13 6275. It is the intent of the Legislature to assist
14 members of the public and state and local agencies in
15 identifying exemptions to the California Public Records
16 Act. It is the intent of the Legislature that, after January
17 1, 1999, each addition or amendment to a statute that
18 exempts any information contained in a public record
19 from disclosure pursuant to subdivision (k) of Section
20 6254 shall be listed and described in this article. The
21 statutes listed in this article may operate to exempt
22 certain records, or portions thereof, from disclosure. The
23 statutes listed and described may not be inclusive of all
24 exemptions. The listing of a statute in this article does not
25 itself create an exemption. Requesters of public records
26 and public agencies are cautioned to review the
27 applicable statute to determine the extent to which the
28 statute, in light of the circumstances surrounding the
29 request, exempts public records from disclosure.
