#### LETTER OF INTENT

The following letter of intent was ordered printed in the Journal:

November 21, 2002

*The Honorable John Burton*

*President Pro Tempore*

Dear Senator Burton: This letter is written to clarify the intent of my 2002 legislation, SB 1045 (Chapter 1165, Statutes of 2002), pertaining to outreach in public contracting and employment.

SB 1045 allows state and local public agencies to conduct focused outreach to minorities and women as a component of a general outreach program.

Specifically, I refer to Section 11139.6 (b), as added to the Government Code by SB 1045. That section defines the method by which public agencies shall make a determination of underrepresentation of disadvantaged groups. The section directs a governmental agency to compare the minority group or the number of women at an agency with that group's representation in the current civilian labor force in the jurisdiction of the governmental agency.

This letter clarifies that the agency's determination under the above-cited section is intended to compare each group segment individually (i.e. specified minority group, such as Black, Hispanic or Asian, or women), rather than comparing a composite of all disadvantaged groups.

On the contracting and procurement section of the measure, the data to be collected in accordance with Section 11139.8, as added to the Government Code by SB 1045, is intended to be by minority group (such as Black, Hispanic or Asian), rather than an aggregation of all minority segments.
