Dear Senator Perata:

Last year I successfully authored SB 1818 which substantively improved the state density bonus law. This year I am authoring SB 435 in

order to make important corrections and improvements to last years' measure.

When SB 435 was heard in the Assembly Housing and Community Development Committee the bill was amended in order to not place the bill at risk. One of the amendments restored the law pertaining to subdivision (b) (1). This subdivision relates to whether an applicant "agrees" to construct affordable units. My statement before the committee concerning the amendment was:

The opposition argues that SB 435 undermines inclusionary zoning but has yet to give one example to support their argument. As the analysis of both SB 1818 and SB 435 have said, density bonus law does not preempt the ability local ordinances to require the inclusion of affordable (low, very low or moderate-income) units within a housing development. The opposition has put forward the strained argument that local inclusionary ordinances preempt state density bonus law, but that was certainly not my intent in SB 1818 nor do I believe it was the Legislature's intent in enacting density bonus law in 1979 and SB 1818 last year. A handful of local jurisdictions have argued since 1979 that density bonus law does not apply until inclusionary requirements have been met. The vast majority of cities, counties and experts take the opposite view, as do I. By adding back language that has been in the law since 1979, we will enable this handful of jurisdictions to continue to make their strained argument, but that is not troubling because the language has consistently been interpreted for 25 years by the vast majority of cities, counties and experts to mean that inclusionary requirements count toward meeting density bonus requirements.

When SB 435 was heard on the Senate floor for a vote on concurrence with Assembly amendments, I stated that:

Even though I agreed to an amendment that restored the language in subdivision (b) (1), providing that a developer is entitled to a density bonus if he or she "seeks and agrees" to construct affordable units, the vast majority of cites, counties and experts believe as I do that this language means that any affordable units in a development count toward meeting density bonus requirements, regardless of whether or not the affordable units are required to be constructed by the local government pursuant to a local ordinance.

I am confident that these points settle Legislative interpretation of my actions to amend SB 435.
