Senate Bill 1275: By Senator Scott—An act to amend Section 56836.21 of the Education Code, relating to special education.

Senate Bill 1276: By the Committee on Elections, Reapportionment and Constitutional Amendments (Senators Bowen (Chair), Battin, Murray, Poochigian, and Romero)—An act to amend Section 15101 of the Elections Code, relating to absentee ballots.

Senate Bill 1277: By Senator Alquist—An act to amend Section 1371.4 of, and to add Section 1317.19 to, the Health and Safety Code, relating to health care.

Senate Bill 1278: By Senator Alquist—An act to amend Sections 8870.3, 8870.4, and 8870.71 of the Government Code, relating to the Seismic Safety Commission.

Senate Bill 1279: By Senator Alquist—An act to add Section 17280.7 to the Education Code, relating to school facilities.

Senate Bill 1280: By Senator Morrow—An act to add Section 2357.5 to the Probate Code, relating to incapacitated persons.

Senate Bill 1281: By Senator Romero—An act to add Section 10295.7 to the Public Contract Code, relating to contracts.
