The Archipelago of the Azores, located in the heart of the North Atlantic, halfway between Europe and North America, is made up of nine islands of volcanic origin and constitutes, today, an Autonomous Region of the Portuguese State, endowed with its own organs of government, democratically elected.

Marked by geography, insularity and the difficulties created by the forces of nature, the Azoreans are a courageous people, hard working, solidary and proud, both of their history and of their culture.

Searching for better living conditions, thousands of Azoreans established themselves in the State of California, since the XIX century, settling vast territories and contributing, with their effort and with their work to the development and the progress of this important State of the American nation.

According to recent estimates, over 500 thousand Azoreans and Azorean descendants live in California today, occupying significant positions in all sectors of activity, while maintaining their ethnic and cultural characteristics, thus enriching the communities where they live and work.

These are the reasons that led the Legislative Assembly of the Autonomous Region of the Azores to adopt its Resolution no 15/2002/A, dated October 30th of 2002, declaring, in the name of the Azorean people, the desire that the special ties of friendship and cooperation between the Azores and California be developed within an institutional framework.

The present visit of a delegation of the Azorean Parliament to the State of California constitutes, therefore, an additional step towards the fulfillment of this desideratum and the bringing together of our regions and communities, with a view towards the strengthening of a social, political and institutional relationship we hope to make increasingly solid and robust.

In the name of the Azorean people represented in the Legislative Assembly, I offer my greetings to the Senate of California and to the people of this State, presenting my best wishes of happiness, peace and progress for all.
