**Senate Bill 60:** By Senator Cedillo—An act to amend Section 40000.11 of, to amend, repeal, and add Sections 12801.5 and 14610.7 of, to add Sections 1653.6 and 12801.1 to, and to add and repeal Section 12801.9 of, the Vehicle Code, relating to vehicles.
