**Senate Bill 183:** By Senator Corbett—An act to amend Section 15657.3 of the Welfare and Institution Code, relating to elderly and dependent adults.

**Senate Bill 184:** By Senators Alquist and Correa—An act to amend Section 14529.17 of the Government Code, relating to transportation.

**Senate Bill 185:** By Senator Dutton—An act to amend Section 2701 of the Public Utilities Code, relating to water companies.

**Senate Bill 186:** By Senator Dutton—An act to amend Section 2896 of the Public Utilities Code, relating to telecommunications.

**Senate Bill 187:** By Senator Ducheny—An act relating to the Salton Sea.

**Senate Bill 188:** By Senator Negrete McLeod—An act to add Section 6588.3 to the Government Code, relating to joint exercise of powers.

**Senate Bill 189:** By Senator Harman—An act to add Section 19816.13 to the Government Code, and to add Section 2811 to the Labor Code, relating to employment.
