# **MESSAGES FROM THE GOVERNOR**

Governor's Office, State Capitol August 31, 2007

To the Members of the California Senate:

I am returning **Senate Bill 455** without my signature.

As stated in the veto messages of similar bills last year, this is a surplus property bill and, as such, it should be included in the Department of General Services' annual omnibus bill. Furthermore, the disposal of this property, and all other surplus property should be exempt from the California Environmental Quality Act (CEQA). The author has not made a compelling case as to why this bill should be treated any differently. Applying the CEQA process to this surplus property prior to sale may result in missed opportunities for the State to reduce its financial obligations under the voter approved Proposition 60A.

As a result, I cannot sign this bill.

Dear Senator Perata and Members:

This letter to the Journal serves as a clarification to my bill, SB 233. I want to clarify that although SB 233 will change the types of projects for which counties may use design-build procedures, it is not intended to affect the types of projects for which the Santa Clara Valley Water District (District) may utilize those procedures under Section 21162 of the Public Contracts Code. Therefore, the District may continue to utilize the design-build procedures specified in 20133 for its 15-year flood program,

that includes levees, and for building and/or upgrading its water treatment plant facilities.

With the signing of AB 674 (Dutra) in 2001, Section 21162 of the Public Contract Code was created thus granting the Santa Clara Valley Water District the authority to utilize the procedures described in Section 20133 of that Code for its building construction contracts. AB 674 was approved by the Senate on a 40–0 vote and by the Assembly on a 72–1 vote. The bill analyses prepared for the Committee and Floor votes made clear that in approving AB 674, the Legislature was authorizing the District to utilize the design-build bidding procedures for its flood program and water treatment plants.
