UNANIMOUS CONSENT TO PRINT IN JOURNAL

Without objection, the following letter was printed in the Journal.

Dear Senator Perata and Members:

This letter to the Journal serves as a clarification to my bill, SB 803. I want to clarify that it is not the purpose of SB 803 to effect the allocation of federal transportation enhancement (TE) funds to any transportation enhancement activity that is eligible to receive such funds; nor would that be the effect of the measure.

Section 101(a)(35) of Title 23 of the United States Code strictly defines "transportation enhancement activities" as consisting of 12 specified activities, which are the only types of projects that can receive federal TE funds. All but three of the 12 specified activities—the acquisition of scenic easements, archeological planning and research, and the establishment of transportation museums—are the sort that have for decades been ably carried out in this State by community conservation corps and the California Conservation Corps (CCC).

Moreover, since 1992, when the relevant federal law was enacted, to 2005, the three activities conservation corps do not engage in have collectively received merely 4.7 percent of the \$7.1 billion programmed for federal transportation enhancement activities nationally. (National Transportation Enhancement Clearinghouse, Transportation Enhancements: Summary of Nationwide Spending as of FY 2005 (May 2006) at page 17.) During that period, more than 94 percent of TE funds (about \$6.7 billion)) were spent just for TE activities at which local corps and the CCC excel: the construction of bicycle and pedestrian paths and facilities (47.1% or nearly \$3.4 billion), landscaping and scenic beautification (16.3% or nearly \$1.2 billion), the construction of highway overlooks and viewing areas (6.5% or \$473 million), the conversion of abandoned railway corridors into multi-use trails (7.9% or \$564 million), historic preservation (4.3% or \$310 million), environmental mitigation (1% or \$72 million), the rehabilitation of historic transportation buildings and facilities (11% or \$789 million), and billboard removal (3% or \$21 million). There is no reason to think that the allocation of TE funds nationally has been significantly different from that in California.

Caltrans and regional transportation planning agencies cannot allocate federal TE funds to activities that do not fit within the statutory definition of "transportation enhancement activities" Because the CCC and local

corps are able to engage in the vast majority of those activities, the use of TE funds under criteria that give priority in the selection of TE projects to sponsors of eligible projects that partner with or commit to employ the services of a local corps or the CCC, as required by SB 803, would not favor any particular type of TE activity over another. Furthermore, in adopting the implementing guidelines called for by SB 803, the California Transportation Commission can insure that sponsors of the relatively few types of TE projects that are inappropriate for a conservation corps to perform are not prejudiced in the allocation process managed by regional transportation planning agencies.
