Senate Bill 1065—An act to add Sections 52013.6, 52013.7, 52017, and 52018 to the Health and Safety Code, relating to housing, and declaring the urgency thereof, to take effect immediately.

Senate Bill 1178: By Senator Aanestad—An act to amend Section 1687 of the Business and Professions Code, relating to dentistry.

Senate Bill 1179: By Senator Aanestad—An act to amend Section 120335 of the Health and Safety Code, relating to immunizations.

Senate Bill 1180: By Senator Runner—An act to amend Section 32204.4 of the Public Resources Code, relating to parks and open space.

Senate Concurrent Resolution 76: By Senators Torlakson, Alquist, Correa, Cox, Ducheny, Dutton, Kuehl, Maldonado, Padilla, Romero, Steinberg, Vincent, and Wyland (Coauthors: Assembly Members DeSaulnier, Levine, and Ma)—Relative to California Fitness Month.

Senate Concurrent Resolution 77: By Senator Lowenthal (Coauthor: Assembly Member Berg)—Relative to fall prevention.
