California is home to the finest dentists in America, and they need to remain at the head of our dental delivery service system. However, dental hygienists and dental assistants must also be a part of the Dental Board of California regulatory proceedings and oversight of the dental delivery service system.

SB 853 acknowledges the essential dental care provided by California's dental hygienists. This profession has evolved over the past decade and plays a crucial role in providing the highest quality preventive dental care.

Under this bill, the Committee on Dental Auxiliaries of the Dental Board of California will transition into a freestanding Dental Hygiene Committee of California by July 1, 2009. To provide meaningful regulatory oversight, the appointees of the Dental Hygiene Committee of California must have full knowledge of the dental hygiene community and the dental services they provide. Therefore, dental hygienists must have a substantial role and voice on this committee.

To address issues raised in the Governor's veto of SB 534, this bill calls for a full evaluation of fees paid by hygienists and assistants prior to this bill taking effect on July 1, 2009. That evaluation shall assure that fees paid by hygienists and assistants will be effectively used to regulate those professions and protect the dental patients they serve.

Additionally, while not contained in the bill, the Dental Board will establish a permanent three-member Dental Assistant Sub-Committee under the aegis of the Dental Board. The chair of the Dental Assistant Sub-Committee shall be the dental assistant member of the Dental Board. The committee shall be comprised of the following three members:

- (1) The chair, who will be the dental assistant member of the Board
- (2) Two other members of the board, only one of whom may be a dentist

Enactment of this legislation is the result of three decades of hard work in the Legislature and represents the cooperative efforts of dental health care providers in California. In this cooperative vein, let us continue the growth and progress of dental care for all Californians who rely on our dental delivery service system.
