It is not the intent of the bill to provide for the licensure, registration, and regulation of private or public alcoholism and other drug abuse (AODA) counselors. It is my understanding the Department of



Alcohol and Drug Programs within the California Health and Human Services Agency is currently working with this profession to develop a program of licensure, registration, and certification.
