LESTER A. SNOW, previously served as director of the California Department of Water Resources since 2004 and principal in a water resource consulting company from 2001 to 2004. He also served as the Mid-Pacific regional director of the U.S. Bureau of Reclamation. Snow served as the executive director of the CALFED Bay-Delta program from 1995 to 1999 and prior to that, spent seven years as the general manager of the San Diego County Water Authority. His experience also includes six years with the Arizona Department of Water Resources including four years as the Tucson area director. Appointed 02/01/10.

Secretary of Natural Resources Agency, vice, Michael Chrisman, resigned, term ending at the Pleasure of the Governor.

MARK W. COWIN, has served the Department of Water Resources for 29 years in various positions, most recently as deputy director of integrated water management since 2007. He was chief of the division of planning and local assistance from 2002 to 2007 and assistant director for the CALFED Bay-Delta program from 1998 to 2002. Cowin earned a Bachelor of Science degree in civil engineering from Stanford University. Appointed 02/01/10. Effective 02/01/10.

Director of Water Resources, vice, Lester A. Snow, re-assigned, term ending at the Pleasure of the Governor.

PAUL SCHIFINO, is owner and president of Junior Steel Company since 2003 and, Anvil Steel Corporation since 1996. He was a partner for Schifino and Lindon from 1992 to 1996, associate attorney for Strook and Strook and Lavan from 1990 to 1992 and adjunct professor at Georgetown University from 1987 to 1989. Appointed 01/19/10. Effective 02/02/10.

Member, Contractors' State License Board, Department of Consumer Affairs, vice, Cynthia A. Mitchell, term expired, term ending 06/01/13.

LINDA J. BRISKMAN, is retired from the City of Beverly Hills where she served as city council member from 2001 to 2009 and has served on the State Park and Recreation Commission since 2009. She was mayor of Beverly Hills in 2005. Briskman served on the Westside Cities Council of Governments and was co-chair of the Transportation Committee. She was a member and served as chair of the Beverly Hills Planning Commission from 1996 to 2001 and the Beverly Hills Traffic and Parking Commission from 1992 to 1996. Reappointed 01/16/10. Effective 01/29/10.

NANCY E. RYAN, Ph.D., previous deputy executive director for policy at the Public Utilities Commission since 2009 and previous chief of staff and chief energy advisor for President Michael R. Peevey from 2006 to 2009. Prior to that, Ryan was a senior economist and California deputy regional director for the Environmental Defense Fund from 2001 to 2005, deputy director for Ecosystems Program in 2005 and visiting assistant professor for the Goldman School of Public Policy at the University of California, Berkeley from 1996 to 2007. Appointed 01/21/10. Effective 01/21/10.

KEN J. WILLIAMS, is school director for the Universal College of Beauty since 1989, where he previously served as chief operations officer from 2001 to 2008 and vice president from 1995 to 2000 and has served on the State Board of Barbering and Cosmetology since 2007. He worked for Vons Grocery as a clerk from 1973 to 1989 and department head and trainer from 1970 to 1989. Williams is a member of the Advisory Board for Supercuts and El Camino College.
