SHERRY LANSING, is founder and chief executive officer of The Sherry Lansing Foundation since 2005 and has served on the University of California Board of Regents since 1999, currently serving as vice chair. Lansing is chairman and chief executive officer of Paramount Pictures Motion Picture Group since 1997. She is a member of the Independent Citizens' Oversight Committee for the California Institute for Regenerative Medicine. Reappointed 03/02/10. Effective 03/12/10. Member, The Regents of the University of California, term ending

BO DEREK, is an actress since 1974 and has served on the California Horse Racing Board since 2008.
