But there are also other stories, of courage and kindness, moral strength and noble acts in the face of evil.

One of these stories belongs to a woman who died this past January. Her name was Miep Gies, a woman best known for being one of the guardian angels who hid Anne Frank and the others who hid in the secret annex.

An extraordinary thing about Miep Gies was how ordinary she was. She was not a politician or a soldier, she did not hold a position of prominence or power, she was just an ordinary person whose sense of morality, of justice, of compassion, and humanity gave her the courage to act in a way that makes the rest of us marvel, and ask, could I do what she did? If I saw my fellow human beings suffering and in peril would I risk my life for theirs? These are questions that can only be answered when the moment arises.

One of the lessons of the Holocaust is that even in dark times there are those amongst us whose moral character shines as brightly as the stars in the heavens, whose bravery inspires us to act in a way that elevates us all, in a way that reminds us that within each human being dwells a spark of the Divine.

May the Holy One give us the courage to recognize and honor the spark of holiness that dwells inside each human being, so that we might be better at doing God's work of bringing goodness, peace and compassion into the world.—AMEN.
