MEMORIAL FOR SENATOR DAVE COX

A Memorial Resolution

Relative to Memorializing the Honorable Dave Cox

WHEREAS, The passing on July 13, 2010, of a distinguished California resident and devoted civic leader, the Honorable Dave Cox, whose actions and good deeds earned him the respect and admiration of his colleagues and the countless individuals whose lives he touched, brought immense sorrow and loss to people throughout the State of California; and

WHEREAS, As a respected civic leader, Dave Cox was a dynamic role model for all people who believe strongly in their obligation to improve the quality of life for future generations; and

WHEREAS, Born in Holdenville, Oklahoma, to Ruby and Ben Cox, Dave Cox and his parents moved several times during his youth and ultimately settled in Tonkawa, Oklahoma; there he attended Tonkawa High School and welcomed a baby sister, 16 years his junior; and

WHEREAS, In 1956, his parents moved from Tonkawa to Lancaster, California, and before leaving, they made arrangements for Dave to live in the dormitory at Northern Oklahoma Junior College and complete his senior year at Tonkawa High School; and

WHEREAS, Upon graduating in 1956, Dave joined his family in Lancaster and attended one year of junior college at Antelope Valley College, where he played football; he then followed his coach to the University of San Diego (USD), where he was offered a books/tuition scholarship to play football and baseball, and a coach arranged for him to live and work at the Ryan, Sullivan, Bradley and Woolman Mortuary as an embalmer; and

WHEREAS, Dave lived and worked at "the mortch" until graduating from USD in 1961 with a degree in business administration; and

WHEREAS, On January 29, 1966, Dave married Margaret Anne Hargreaves (Maggie) in San Diego, and in 1970, 1971, and 1972, they welcomed daughters Cathleen, Margo, and Sarah, respectively; and

WHEREAS, Dave, who spent most of his professional career in the insurance business, moved to Fair Oaks in 1976 when he became the general agent of the local Penn Mutual office; and

WHEREAS, In 1981, Dave opened his own full-service agency, Integrated Benefits and Insurance Services, Inc., and with Maggie's assistance in the office, he pursued his passion for public service and politics; and

WHEREAS, Dave was elected to the Sacramento Municipal Utility District Board in 1988 and served one term; in 1992, he was elected to the Sacramento County Board of Supervisors to represent the "Fighting Fourth" District; and

WHEREAS, Dave held more than 700 "Community Cabinet" meetings during his political career; and

WHEREAS, Dave served three terms in the California State Assembly from 1998 to 2004, half of which were spent as the Assembly Republican Leader; and

WHEREAS, In 2004, Dave was elected to the California State Senate to represent the large First District, and he was re-elected in 2008; and

WHEREAS, Dave was a member of the North Ridge Country Club and enjoyed playing golf on Saturday mornings—the foursome nicknamed itself the "Fair Oaks Yacht Club"; and

WHEREAS, Dave dispensed his wise counsel as a former member of the Rotary Club of Sacramento, Senior Warden for St. Francis Episcopal Church of Fair Oaks, and 1982 Chair of KVIE-Channel 6; and

WHEREAS, Dave was honored as the alumnus of the year at Tonkawa High School in 2008 and at Antelope Valley College in April 2010; and

WHEREAS, The memory of Dave Cox will live not only through his personal, professional, public, and civic achievements and his contributions to the State of California and the nation, but also for the inspiration he provided to those individuals who were fortunate enough to know him; and

WHEREAS, Dave Cox leaves to cherish his memory his wife of 44-years, Maggie; his devoted daughters, Cathleen Cox, Margo (Matt) Gunderson and Sarah (John) Aquino; his grandchildren, Annalee, Meg, Caroline, and Elsa Gunderson and Ellie and Andrew Aquino; his sister, Mary Alice (Dennis) Foote; his sister-in-law, Annalee (Vito) Tanzi; his beloved Rudy Dog; and an amazing staff; now, therefore, be it
