MESSAGES FROM THE GOVERNOR

Governor's Office, State Capitol August 23, 2010

To the Members of the California State Senate:

I am returning **Senate Bill 1191** without my signature.

The provisions of the Quality Education Investment Act (QEIA) extend far beyond the role and use of school counselors. This bill narrowly intends to evaluate pupil-counselor ratios, rather than the quality of the counseling programs. I am concerned that focusing on pupil-counselor ratios in the final evaluation of the effectiveness of QEIA would not provide as meaningful information as the impact of the equitable distribution of quality teachers between schools, quality professional development, and sufficient instructional materials.

For this reason, I am unable to sign this bill.

Governor's Office, State Capitol August 23, 2010

To the Members of the California State Senate:

I am returning **Senate Bill 1434** without my signature.

This bill creates a rebuttable presumption that allows a county elections official to process a voter registration form when an individual leaves the "U.S. state or foreign country of birth" section blank, as long as the box certifying he or she is a citizen of the United States has been checked and signed.

A person's citizenship, not their state or country of birth determines their eligibility to vote. The uniform federal application recognizes this fact and does not require this information; including it on the state form is unnecessary. As a naturalized citizen of this great country, my place of birth did not deter my registration eligibility and I am proud to exercise my right to vote.

Allowing registrants to leave the "U.S. state or foreign country of birth" section blank would render it useless. The most direct fix to the discrepancy between the state and federal forms is to remove the line from the state form.

RE: Letter to the Journal—Senate Bill 1034 relating to property potentially covered under "Public Lands" definition.

Dear Senator Steinberg:

I respectfully request this letter to be entered into the Senate Journal to clarify that the definition for "Public Lands" in subdivision (b) of

Section 5097.5 of the Public Resources code should not be read to include private property generally. Section 5097.5 specifically provides as follows:

"5097.5. (b) As used in this section, 'public lands' means lands owned by, or under the jurisdiction of, the state, or any city, county, district, authority, or public corporation, or any agency thereof."

On June 30th 2010 The Legislative Counsel Bureau issued a written opinion on this issue. Counsel came to the conclusion:

"that the definition of "public lands" in subdivision (b) of Section 5097.5 of the Public Resources Code does not include private property generally, but rather includes only private property over which a public entity listed in that subdivision has a sufficient property interest or legal right of administration or control such that it could grant consent for the activities otherwise prohibited by that section."

This opinion makes it clear that the law applies only to "public lands," meaning property that is owned by a government entity, or for which a government entity has a legal property right that would permit it to grant the consent in question.
