Re: Letter to the Journal, Senate Bill 1173 (Wolk)

Dear Mr. Schmidt:

I am submitting this letter to the Senate Daily Journal regarding Senate Bill 1173.

Senate Bill 1173 authorizes the State Water Resources Control Board to find that the use of raw water, as defined in the bill, is a waste if recycled





water is available, as set forth in existing law and as specified in the bill. One of the factors that existing law requires the Board to consider in determining whether recycled water is available is whether it is cost-effective. Existing law also provides protections for existing water rights where recycled water is used in place of potable water.

It is my intent under SB 1173 that the Board's determination of whether recycled water is cost-effective should take into account any capitol costs to the water user associated with switching to recycled water, and that those costs be considered over a reasonable cost-recovery period related to the capitol expenditure in question. This is consistent with current law, particularly existing Water Code section 13550(a)(2), and the current practice of the State Water Resources Control Board. This is reflected, for example, in Water Rights Decision 1623 (1990), in which the costs taken into consideration included "the users' amortized capitol costs (for pipelines, site conversion costs, if any, etc.)."

It is also my intent, that SB 1173 will not change existing law regarding the protection of water rights for those that make use of recycled water. Specifically, any use of recycled water, including use required under Water Code section 13550, in lieu of raw or potable water will not result in any impairment of an existing water right for the raw or potable water. This is reflected in existing law, including:

Water Code section 13551 (as amended by SB 1173), which provides that the "use of recycled water in lieu of raw or potable water shall, to the extent of the recycled water so used, be deemed to constitute a reasonable and beneficial use of that water and the use of recycled water shall not cause any loss or diminution of any existing water right." (emphasis added). The emphasized word "that" in this provision of the Water Code refers to the raw or potable water in lieu of which recycled water is used.

Water Code section 1010(a)(1), which provides that the "cessation of, or reduction in, the use of water under any existing right regardless of the basis of right, as the result of the use of recycled water, desalinated water, or water polluted by waste to a degree which unreasonably affects the water for other beneficial uses, is deemed equivalent to, and for purposes of maintaining any right shall be construed to constitute, a reasonable beneficial use of water to the extent and in the amount that the recycled, desalinated, or polluted water is being used not exceeding, however, the amount of such reduction."

To the President pro Tem and the Members of the Senate:

As the author of SB 1440, which would streamline the transfer of students from California Community Colleges (CCC) to California State University (CSU) campuses, I wish to provide further information on my intentions regarding the elements and follow-up activities regarding this bill.

As this bill was in its final committees, it became clear to all parties that there are a number of complex implementation issues which must be addressed and will need further work and clarification.

Both CSU Chancellor Charles Reed and CCC Chancellor Jack Scott recognize the need to address these issues. They have proposed a joint SB 1440 Implementation Task Force to clarify and address remaining issues prior to implementation of the new transfer law. The Task Force may also make recommendations for further legislation, regulatory changes, or other policy changes. I expect both Chancellors to seek input from the various stakeholders in addressing the implementation details.

Further, SB 1440 does not seek to change, and should not be construed to change, the current priority admissions for individuals established in Education Code Section 66202 (b) and 66202 (c), such as veterans. An individual admitted pursuant to Article 3 (commencing with Section 66745) of the Education Code as enacted by SB 1440 shall receive the



current priority consideration afforded in the Education Code Section 66202 (b) and 66202 (c). I will seek legislation at the earliest opportunity to clarify and codify this intent in statute. I have a strong record voting in favor of veterans and veterans' issues. As recently as the 2007–2008 legislative session, I voted in favor of SB 272 authored by Senator Runner which granted priority registration for enrollment to individuals in the military that are within 2 years of leaving active duty.

In addition, I will monitor the implementation of this measure after it is chaptered to assure that it results in increased numbers of transfer students with the most efficient use of CCC and CSU course offerings.
