Re: Letter to the File—SB 957 (Price)

Dear Senator Steinberg:

I am writing this letter to provide additional information regarding the intent of SB 957.

The Cal Grant C awards, administered by the California Student Aid Commission, assist students across the state with fees, tuition, and training-related costs such as special clothing or required tools in occupational or vocational programs of four months or more. Current law provides that grants may be renewed until the completion of the training, up to a maximum of two years. Under the provisions of SB 957, student eligibility requirements would not change, but the Student Aid Commission will implement a procedure whereby priority will be given to applicants that are pursuing training in statewide high-growth, high-need, and high-wage occupational areas. The bill also requires bi-annual reports on the program by the Legislative Analyst Office on or before April 1, 2014, and on or before April 1 of each even-numbered year thereafter.

Although SB 957 seeks to prioritize Cal Grant C awards based on statewide labor market needs, the Legislature recognizes that there may be some displacement of current Cal Grant C recipients. The Legislature also recognizes the importance of ensuring Cal Grant C students are able to attend and complete their educational goals in programs and at institutions that will ensure successful job placement.

According to the Student Aid Commission, implementation of SB 957 may result in some displacement of students attending certain programs and institutions. Although current displacement estimates by the California Student Aid Commission are relatively low (approximately 10%), it is not the intent of SB 957 that there be major displacement of existing Cal Grant C recipients, particularly for those students enrolling and completing programs at schools that have a strong track record of job

placement. However, the Legislature also recognizes that there must be stronger guidelines for how our state funds are used to meet the demands of the statewide labor market. Without a doubt, many California employers have benefited from the strong technical skills of Cal Grant C recipients under current program guidelines. To the extent feasible under SB 957, the Legislature recognizes the need for balance between institutions with a proven track record of job placement and meeting the demands of the statewide labor market by prioritizing Cal Grant C funds to students who are pursuing occupational training programs that meet the three criteria specified in SB 957.

Based on the above, it is my intent to request that as part of the process for developing and implementing regulations, the Student Aid Commission consider, to the extent allowable under the law, the local and regional labor market needs and program job placement rates of institutions. In addition, it is my intent that the Legislative Analyst should include in their report to the Legislature additional information regarding the impact of displacing current Cal Grant C recipients, what schools and programs these students are attending and the extent to which students were successfully placed in jobs that met the local, regional or state workforce needs.

My colleagues and I in the Legislature are committed to ensuring the best possible outcome for students and the state, and will examine the results of the changes implemented under SB 957 closely.
