Senate Bill 145: By Senator Wyland—An act to amend Section 1770 of the Labor Code, relating to public works.

Senate Bill 147: By Senator Leno—An act to add Section 19161.7 to the Business and Professions Code, relating to furniture.

Senate Bill 148: By Senator Steinberg—An act to add and repeal Article 5.5 (commencing with Section 54698) of Chapter 9 of Part 29 of Division 4 of Title 2 of the Education Code, relating to partnership academies.

Senate Bill 149: By Senator Correa—An act to amend Section 798 of the Civil Code, relating to mobilehomes.

Senate Bill 150: By Senator Correa—An act to amend Section 1102 of the Civil Code, relating to residential property.

Senate Bill 151: By Senator Correa—An act relating to state employees, and declaring the urgency thereof, to take effect immediately.

Senate Bill 152: By Senator Pavley—An act to repeal Section 6503.5 of the Public Resources Code, relating to public lands.



Senate Concurrent Resolution 7: By Senator Huff (Coauthors: Senators Dutton, Fuller, and Harman) (Coauthors: Assembly Members Allen, Block, Blumenfield, Donnelly, Fletcher, Jeffries, Portantino, and Williams)—Relative to celiac disease.
