Re: Legislative Intent—Assembly Bill No. 793

Dear Secretary of the Senate Schmidt:

We are providing this joint letter to the Journal to document the intent of the author and the Senate Insurance Committee for Assembly Bill 793 concurrent with its passage today.

When AB 793 was heard in the Senate Committee on Insurance, a concern was raised that its provisions could be construed or applied to trigger an inadvertent violation by an insurance agent or broker where a consumer, having previously secured a reverse mortgage, subsequently seeks to obtain a noncasualty insurance product from the producer or licensee.

AB 793 has been patterned as the Insurance Code complement to AB 329 (Chapter 236, Statutes of 2009), known as the “Reverse Mortgage Elder Protection Act of 2009” (“Act”). This Act places restrictions on originators of reverse mortgages having subsequent financial and insurance transactions with their reverse mortgage customer unless the reverse mortgage originator maintains procedural safeguards and other appropriate consumer protections, as specified in the Act.

In the same way, it is not the intent of AB 793 to prevent a senior from purchasing noncasualty insurance products from an insurance broker or agent, such as an annuity or long-term care insurance, when the purchase



is independent of a reverse mortgage loan referral. Also, like AB 329, AB 793 intends that this independence can be shown by the broker or agent maintaining procedural safeguards designed to ensure that the agent or broker transacting insurance has no direct financial incentive to refer the policyholder or prospective policyholder to a reverse mortgage lender.

AB 793's aim is to address insurance agents and brokers who, with full knowledge that a senior has recently acquired a reverse mortgage, inappropriately solicit those funds for the purpose of selling a noncasualty insurance product. Outside of an improper referral prohibited by this measure, if a senior independently wishes to purchase an insurance product with the proceeds of a reverse mortgage, that action would be permissible under this bill as described above.

Senate Bill 614 (Kehoe) (Chapter 123, Statutes of 2011) provides a 30-day grace period for all continuing Grade 7–12 students to continue to



attend school in their district of prior attendance at the start of their 2011–12 school year, while they seek and obtain verification of pertussis booster immunization. Legislation passed in 2010 (AB 354, Chapter 434, Statutes of 2010) established the immunization requirement.

The 30-day grace period in SB 614 intends to apply to all students who are continuing in or advancing to grades 7–12. Because current law treats some pupils, schools and districts differently when it comes to certain immunization requirements, I wish to clarify that SB 614 is intended to apply to: 1) students advancing from an elementary feeder school district to its recipient high school district, 2) community school students returning to their district of prior attendance, and 3) charter school students returning to their regular school district of attendance from a charter school.

Thank you for noting the intent of this measure.

Dear Senator Steinberg:

I write to clarify one provision of SB 563 relating to common interest development (CID) meetings. This bill generally prohibits CID boards from taking action on items of business outside of an open meeting, but the language of proposed Civil Code Section 1363.05(j)(2)(B) specifically allows a CID board to conduct an electronic meeting in an emergency situation, as defined, if all the members of the board consent in writing to actions taken in the emergency meeting.

In the Assembly Judiciary Committee I added a sentence to the proposed Civil Code Section 1363.05(j)(2)(B) that states, “Written consent to conduct an emergency meeting may be transmitted electronically.” The intent of this provision is solely to clarify that board members may electronically submit the written consents required to take an action in an electronic emergency meeting. The language is not intended to, and does



not, imply that all board members must consent to hold an emergency meeting, electronically or otherwise.

I appreciate the opportunity to clarify any potential misunderstanding in this manner.
