Senate Bill 1082: By Senator Corbett—An act to amend Sections 6205.5, 6206, 6206.5, 6206.7, 6207, 6210, and 6215.2 of the Government Code, relating to the protection of victims.

Senate Bill 1083: By Senator La Malfa—An act to amend Section 15104 of the Elections Code, relating to elections.

Senate Bill 1084: By Senator La Malfa—An act to amend Section 56001 of the Government Code, relating to local government.

Senate Bill 1085: By Senator La Malfa—An act to amend Section 12578 of the Water Code, relating to water resources.
