In order to address this concern, Wiseburn School District will pursue a State Board of Education waiver of the new SB 477 provision and request to use the revenue limit calculation in current law.

This letter also confirms that the Wiseburn School District will not ask for approval of a new unified revenue limit for the district, unless it is calculated consistent with the law applicable to all districts.

On August 29, 2012, the Senate passed AB 1478 (Committee on Budget and Fiscal Review) which includes appropriations for the Department of State Parks and Recreation. Prior to the passage of this bill, it was determined that the balance in the Off-Highway Vehicle Trust Fund was not accurately displayed in the Governor's Budget. Currently, there are both accounting and legal audits being undertaken by the administration to discover the true balance in this and other special funds, and until the investigations into this fund have been completed, it would be premature to appropriate additional funding to the department for the Off-Highway Vehicle Division.

It is my intent that should additional funds be determined to be available in the Off-Highway Vehicle Trust Fund that are sufficient to fund programs historically funded by the Off-Highway Vehicle Trust Fund, that these funds should be appropriated by the Legislature as soon as practicable. At a minimum, it is my intent that the Committee on Budget and Fiscal Review will address this issue at the beginning of session in 2013.

The Legislature recently passed SB 289 (Hernandez) which allows programs and schools training Clinical Laboratory Scientists (CLS) for licensure by the California Department of Public Health to use multiple laboratories for the training of these individuals if the program ensures that all training is completed.

The Business and Professions Code (B&P) Section 1213 states the following, “As used in this chapter, “school” means any place, establishment, or institution organized and operated to offer training for one or more of the personnel classifications included in this chapter or the regulations pertaining thereto.”

SB 289 uses the term “program” when referring to entities engaged in CLS training in clinical laboratory techniques. It is the intent of this legislation that the use of the term “program” as stated in SB 289 amended B&P 1222.5 and specified in (a), (b), and (b)(1), (b)(2), (b)(3), and (b)(4) to be synonymous with the definition of “school” in B&P Section 1213.

Re: Legislative Intent—Senate Bill No. 163

Dear Mr. Schmidt:

I respectfully submit this letter to be printed in the Senate Journal in order to reflect the intent of Senate Bill 163 (Stats. 2011, Ch. 417).

SB 163 changed the governance structure of the State Bar of California. Before January 1, 2012, the State Bar was governed by a board known as the Board of Governors of the State Bar. The 23-member Board of Governors consisted of 15 elected attorney members; six appointed public members; a representative of the California Young Lawyers Association; and the State Bar President.

SB 163 revised and recast these provisions by renaming the Board of Governors as the Board of Trustees and revising the composition of the board. SB 163 required that the Board of Trustees be reduced from 23 to 19 members by no later than October 31, 2014. The 19 board members will consist of six appointed public members and 13 attorney members who will be selected as follows: six elected, one each from the six new State Bar Districts based on California’s six appellate court districts; five appointed



by the Supreme Court; one appointed by the Senate Committee on Rules; and one appointed by the Speaker of the Assembly.

With respect to board members who commenced serving on the board prior to December 31, 2011 only, SB 163 was not intended to impact their ability to be elected State Bar President during their third year of service and to serve a fourth year as State Bar President. This conforms to the State Bar governance structure that existed before SB 163 was enacted, at the time those board members were elected or appointed, and will ease the transition from a 23-member board to a 19-member board. This would impact the size of the board only for the 2014–2015 year.

Thank you for noting the intent of this measure.

Dear Mr. Schmidt:

I have authored SB 1172 to protect children and adolescents from the dangers caused by sham treatments often called reparative therapy, conversion therapy or reorientation therapy. These sexual orientation change efforts attempt to convert or “repair” a minor’s sexual orientation.

This bill would prohibit a mental health provider from engaging in sexual orientation change efforts (SOCE), as defined, with a patient younger than 18 years old. This bill further provides that any SOCE attempted on a minor by a mental health provider shall be considered unprofessional conduct and subject the provider to appropriate discipline.

This discriminatory practice of seeking to change an individual’s sexual orientation is not supported by any credible research and has been highly discouraged by mental health professional organizations for years, but the law has been silent on SOCE.

Clearly, children and adolescents under the age of 18 should have access to appropriate psychotherapy during critical developmental periods. For some children and adolescents, a therapeutic setting is the only open and safe place to grapple with some of the most difficult and uncomfortable issues they face growing up. The intent of this legislation is not to reduce or lessen the availability of such legitimate therapy.

Further, it is not the intent of this bill to restrict psychotherapy exploration of sexual feelings or actions, or to regulate the psychotherapy process of exploring one’s identity and orientation. It is not the intent of this bill to restrict the voluntary treatment of paraphilia, e.g. voyeurism, among other customary subjects of psychotherapy treatment. The bill language



makes clear, however, that same-sex attractions and behaviors and gay, lesbian, or bisexual sexual orientations are not paraphilias, and that efforts to change them constitute prohibited unprofessional conduct.

Additionally, it is my intent that the state's licensing boards and courts be appropriately discerning in adjudicating any cases brought to them relative to the passage of this bill. Only mental health professionals who have intentionally attempted to change the sexual orientation of their minor patients would be subject to professional discipline.
