PRAYER

Upon invitation of the President, the following prayer was offered by Senator Roderick Wright:

Members and guests have you ever noticed how everyone seems to be in a hurry these days? Between smart phones email, Facebook and other social media it seems like everyone is trying to squeeze more out of every minute. People are texting while driving; most of us have devices at our bedsides. I have even seen guys on the phone in the restroom! At some point you must ask yourself, is it really that serious? During meetings folks will have two or three devices they are monitoring while trying to pay attention to the meeting. I don't know if the new technology is making us more productive or less patient? Have you noticed that the jasmine is fragrant and in bloom around the Capitol building? You will only know that if you "Slo Yo Roll" or take your time. Now you might need some Zyrtec walking in Sacramento this time of year, but you get my point.

The other day I was listening to one of my favorite bands, named for my hometown they are simply known as Chicago. The song and my theme today is, "Does Anybody Really Know What Time It Is?" It is often said, patience is a virtue. In the book of Galatians the apostle Paul wrote, "But the fruit of the spirit is love, joy, peace, patience, kindness goodness and faithfulness." But with all our high tech stuff, we seem to be spending more time and accomplishing less. Dear President Pro Tem Steinberg:

I respectfully submit this letter to the Senate Journal regarding Assembly Bill 94 relative to the State Budget Act of 2013–14 and the General Fund support to the University of California in Item 6440-001-0001.

It is my intent as the manager of this measure, and as Chair of the Senate Committee on Budget and Fiscal Review, that the moneys allocated from Item 6440-001-0001 of Section 2.00 of the Budget Act of 2013–14, in the sum of fifteen million dollars (\$15,000,000), be allocated to the Regents of the University of California for the School of Medicine at the University of California, Riverside (UCR), on an ongoing basis.

In allocating these funds, I recognize that ongoing funding for the School of Medicine at UCR is critical, not only to provide for the planning and startup costs associated with academic programs, but also for the ongoing operating support for faculty, staff and other annual expenses necessary to ensure the success of the program.

Furthermore, it is also my intent that the Regents of the University of California shall only use the moneys allocated from Item 6440-001-0001 of Section 2.00 of the Budget Act of 2013–14, in the sum of fifteen million dollars (\$15,000,000), for the sole purpose of funding the School of Medicine at the University of California, Riverside, and shall not redirect or otherwise expend these moneys for any other purpose. Nor shall the

funding be used to supplant other funding of the Regents of the University of California for the School of Medicine at UCR.

The ongoing allocation of fifteen million dollars of state funding to the UCR medical school will add more physicians to underserved areas in inland southern California and help California meet the objectives of the federal Patient Protection and Affordable Care Act (Public Law 111-148) in the short-term and the long-term by expanding the physician workforce.

I am confident the Regents of the University of California will honor the intent on this allocation.
