Re: SCA 3 (Leno) Open Records and Meetings Letter to the Journal Dear Mr. Secretary:

In 2004, nearly 83 percent of voters approved Prop. 59, known as the Constitutional Sunshine Amendment. Its central provision, Article 1, Section 3(b)(1) states: "The people have the right of access to information concerning the conduct of the people's business, and, therefore, the meetings of public bodies and the writings of public officials and agencies shall be open to public scrutiny."

SCA 3 amends Article 1, Section 3 of the Constitution to provide that: "In order to ensure public access to meetings of public bodies and the writings of public officials and agencies, . . . each local agency is hereby required to comply with the California Public Records Act (CPRA) . . . and the Ralph M. Brown Act (Brown Act) . . . "

Like many other provisions of the Constitution that refer to statutes, statutory schemes, or Budget Acts, the Legislature in SCA 3 does not intend to incorporate either the CPRA or Brown Act provisions directly into the Constitution and prevent future amendments of those provisions by the Legislature. Instead, the Legislature in SCA 3 simply declares that compliance with the CPRA and Brown Act is essential to the implementation of Article 1, Section 3 (b) of the Constitution, that compliance with those acts by local agencies is a matter of constitutional principle and not just a statutory mandate, and that the costs incurred by local agencies for compliance with the statutes are not subject to reimbursement pursuant to Article XIII B as a state mandated local program. Further, the Legislature does not intend SCA 3 to grant the CPRA and Brown Act constitutional stature nor change the rules for compliance with those laws. Nor does the Legislature intend SCA 3 to restrict or limit the ability of the Legislature to enact any future amendment to the CPRA or Brown Act, whether to expand or limit the public's rights of access under those statutes when appropriate findings are made. SCA 3 also does not require any future amendment of the CPRA or Brown Act to be voted on by the people. However, it does exempt from the state reimbursement mandate those laws and any future amendment made with findings showing that the amendment furthers the purpose of Article 1, Section 3.

In short, SCA 3's simple cross-referencing of the statutory standards for compliance with the CPRA and the Brown Act do not "constitutionalize" the CPRA and Brown Act provisions in the sense that it directly adopts the words of those acts into the Constitution and prevents future legislative amendment of those acts. SCA 3 does not do that. Nor does it "constitutionalize" the exemptions and limitations under those statutes.

SCA 3 does not change the standards for compliance with those statutes, but instead provides that compliance with those provisions is a constitutional mandate and not a state reimbursable mandate under Section 6 of Article XIII B.
