Second Reading of Bills—Author's Amendments

Assembly Bill 687—An act to amend Section 365.1 of the Public Utilities Code, relating to electricity.

Bill read second time.

The amendments were read and adopted and the measure ordered printed and re-referred to the committee.

INTRODUCTION AND FIRST READING OF SENATE MEASURES

The following measures were introduced, read the first time and transmitted to the Committee on Rules for assignment:

Senate Bill 940: By Senator Jackson—An act to amend Section 1913 of the Code of Civil Procedure, to add Section 70663 to the Government Code, and to amend Sections 1471, 1821, 1834, 2107, 2200, 2300, 2352, 2650, and 3800 of, to add Section 1851.1 to, and to add Chapter 8 (commencing with Section 1980) to Part 3 of Division 4 of, the Probate Code, relating to conservatorships.

Senate Bill 941: By Senators Monning and DeSaulnier—An act to add Article 1.4 (commencing with Section 678) of Chapter 5 of Division 3 of the Harbors and Navigation Code, relating to vessels.

Senate Bill 942: By Senator Vidak—An act to amend Section 13001 of the Elections Code, relating to special elections, and declaring the urgency thereof, to take effect immediately.

Senate Bill 943: By Senator Beall—An act to amend Section 19130 of the Government Code, relating to civil service.

Senate Concurrent Resolution 80: By Senator Corbett (Coauthor: Assembly Member Mullin)—Relative to Irish American Heritage Month.
