I would like to clarify my vote in support of AB 777 (Murasutchi). I believe the bill would exempt taxes on space flight vehicles, and under this belief, I cast an "aye" vote for the bill. Per added Revenue and Taxation Code Section 242, qualified property as it is described for space launch vehicles should be construed to encompass vehicles that are air-launched, vertically-launched or launched from a runway and each stage of a multi-stage launch vehicle that are necessary components to achieve spaceflight, regardless of whether these stages remain in the atmosphere.

Launch vehicles that are solely used for space flight should be included in the definition of qualified property for the exemption set forth by the intent in Assembly Bill 777.
