Dear Senator Steinberg:

I submit this letter to the Senate Daily Journal to clarify the term “license plate type” as used in Senate Resolution 28 (Transportation and Housing Committee) that the Senate adopted by a 34–0 vote on April 10, 2014.

SR 28, among other things, declares a moratorium on legislation “to increase the number of license plate types” that the Department of Motor Vehicles may issue until an assessment of the impact of increased license plate types is completed. To clarify, the phrase “license plate type” as used in SR 28 does not include a specialized license plate that a state agency sponsors under its authority in Article 8.6 of Division 3 of the Vehicle Code, which allows any state agency to sponsor a plate—with or without further legislation—provided the license plate design complies with the design criteria specified in Vehicle Code Section 5155.

The moratorium in SR 28, therefore, does not apply to bills that simply direct a specified state agency to sponsor a plate under this existing law and pursuant to the design criteria in Section 5155. The moratorium would apply to a bill that authorizes a license plate that does not comply with those guidelines.
