Letter to the Senate Journal Re: SB 962 (Leno)

SB 962 requires smartphones manufactured after July 1, 2015, and sold in California after that date to include a technological solution at the time of sale that can render the essential features of the smartphone inoperable when not in the possession of the authorized user, as specified.

SB 962 was amended in the Assembly on August 4, 2014 to add the following clause, intended to clarify explicitly that smartphone theft is a matter of statewide concern, and to narrowly pre-empt local governments from enacting individual ordinances regulating theft-deterrent technological solutions for smartphones.

(h) The Legislature finds and declares that the enactment of a uniform policy to deter thefts of smartphones and to protect the privacy of smartphone users if their smartphones are involuntarily acquired by others is a matter of statewide concern and no city, county, or city and county shall impose requirements on manufacturers, operating system providers, wireless carriers, or retailers relating to technological solutions for smartphones.

This provision was drafted to apply solely to the purposes of SB 962, specifically, theft-deterrent technological solutions for smartphones. The term “technological solution” as it is used in the bill, and in the legislative findings and intent language, clearly refers to theft-deterrent technology. However, this letter is hereby submitted to the journal to re-emphasize and clarify that fact explicitly, and to state that the Legislature’s intent in approving the above referenced provision is not to pre-empt local governments from taking any actions whatsoever, except with specific regard to theft-deterrent technological solutions for smartphones.
