#### PROCEEDINGS OF THE SENATE

The hour of 12 o'clock m., having arrived, Lieutenant Governor Gavin Newsom, President of the Senate, in accordance with Article IV Section 3(a), of the Constitution of the State of California, called the Senate to order and announced that the 2015–16 Regular Session of the Legislature was about to convene, and informed the Senators that, pursuant to Section 9150 of the Government Code, Daniel Alvarez, Secretary of the Senate; Debbie Y. Manning, Sergeant at Arms, and Neva Marie Parker, Minute Clerk were in their respective places.

#### **PRAYER**

Upon invitation of the President, the following prayer was offered by Father Gregory J. Boyle, S.J.:

What Martin Luther King says about church could well be said of this gathering this afternoon: that it is not the place you've come to, it is the place you will go from. And we go from here with a vision of wanting the world to look differently than it currently looks.

The prophet Habakkuk writes: the vision still has its time, presses on to fulfillment, and it will not disappoint. And if it delays, wait for it. But none of us want to wait for too long con los brazos cruzados, staring at our feet and watching our watches. We want to imagine something different. And so with God, we imagine a circle of compassion and then we imagine nobody standing outside that circle. We pray and hope for leaders who will know how to dismantle the barriers that exclude; who know how to stand at the margins with the poor and the powerless and the voiceless, with those whose dignity has been denied, and those whose burdens are more than they can bear. We hope and pray for leaders who know how to stand with the easily despised and the readily left out, with the demonized so that the demonizing will stop, and with the disposable so that the day will come when we stop throwing people away. We go from this place and we stand against forgetting that we belong to each other. We stand always as enlightened witnesses, people who, through Your kindness and tenderness and focused intent of love, return people to themselves. And so we hope and pray for leaders who will know how to obliterate the illusion that we are separate. We go from here to measure the health of our communities in their ability to stand in awe at what the poor have to carry rather than stand in judgment at how they carry it. For in the end, the measure of our compassion will always reside not in our service of those on the margins, but in our willingness to see ourselves in kinship with them. And so because this is an event and a moment from which we will eventually leave, we bow our heads and pray:

God of all compassion, who dreams of our kinship with each other. You, who love us without measure and without regret. You, who are too busy loving us to have any time left for dismay or disappointment; guide us to be in the world who You are, compassionate, loving, and kind. Lead us to seek Your exquisite mutuality with the least and the lost and the last. Help us to measure our success always in our fidelity to the care of the widow and the orphan and the stranger. So grant us this day and always, Your way of seeing Your vision; for the vision still has its time, presses on to fulfillment and it will not disappoint. And if it delays, we wait for it. Que Dios nos bendiga, nos accompañe, nos protege de todo mal, de lo pedimos todo. Por Christo nuesto Señor.—AMEN.

# ADDRESS BY PRESIDENT PRO TEMPORE

Hello my fellow Californians, it is great being with each and every one of you here on this special day.

Today marks a new chapter for all of us to work together and get things done for the people of California. This legislative body leads the nation, time and time again, in enacting policies that are important to all Americans. What we do here matters and I am extremely proud of what we have accomplished together. It is an honor to serve as your President pro Tempore of the California State Senate. I thank you for this humbling opportunity

What does the Latin word pro Tempore mean? The meaning might represent one of the most populist and democratic ideas I can think of. Pro Tempore means "of the moment." It's a title that says, "the individual leader is fleeting, but the institution lives on." It instills us with a sense of both urgency and humility. Environmental protection and advanced public transportation are essential for our quality of life and productivity.

Improved human relationships and respect for cultural diversity are the vital moral foundation for a free, just and creative society.

None of these crucial goals can be achieved if we ignore any of them. The message I have for you all today is that the stakes are too high for us not to get this right.

I grew up in a neighborhood that is living proof of what happens when we get it wrong. What happens when public policy lets a neighborhood, a community, a people fail. Many of the kids I grew up with ended up on drugs, in gangs, in prison or dead. I would not be here today if it were not for the hard work and dedication of my mother, a single immigrant woman with 3 children. The fact that I made it out to accomplish bigger things shouldn't be the exception, it should be the rule. There is nothing exceptional about me. What IS exceptional are the policies that were vigorously debated under this Capitol dome on this very Senate floor that gave me, as well as others here today, the opportunity to succeed. I am living proof that the work we do here matters. The work we do here can secure the ladder of opportunity for all of our children, no matter where they come from.

Now, we just finished a very competitive election cycle and today is the day we stop being politicians and officially become Senators. No more polls, no more rhetoric. It's time for us to deliver results for the communities and neighborhoods that sent us here. Now that we have been sworn in, good governance is no longer just a matter of opinion—it's now our job to make sure our institutions function well. It can no longer just be a talking point that we need to have the best schools in the world. Our kids only get one shot at a good education and it's our duty to make that happen for them. It can no longer just be a belief that if a person works hard and plays by the rules they should be able to provide for their family. It's our job now to make that a reality. Partisanship, on both sides, won't give our neighborhoods more green parks. Partisanship won't provide our children with clean air or water. And campaign money won't keep our neighborhoods safe. Debate and dissent are good. In fact, better ideas come out of heated debates. But we must always do so coming from a place where we understand that every one of us has good intentions. Every one of us wants California to have a dynamic economy where residents can get a job and also pursue their dreams. Every one of us wants to ensure that there's a fantastic teacher in every classroom. Some of us may disagree on how the state should function, but none of us disagree on whether it should function.

So today, we will refocus our efforts on truly what it means to be an elected delegate of the people of California. Whether it's the first time you serve, or you are a seasoned veteran, today we renew a contract with the neighborhoods and communities we represent. The people of California have placed their trust in us. Now it's time to earn it.

We don't get to serve forever. We are, ALL of us, Tempores, "of the moment" and, colleagues, our clock starts now.
