Senate Bill 192: By Senator Liu—An act to amend Section 21212 of the Vehicle Code, relating to bicycles.

Senate Bill 193: By the Committee on Veterans Affairs (Senators Nielsen (Chair), Allen, Hueso, Nguyen, and Roth)—An act to amend Section 64 of the Military and Veterans Code, relating to veterans.

Senate Bill 196: By Senator Hancock—An act to amend Section 15657.03 of the Welfare and Institutions Code, relating to elder abuse.

Senate Bill 197: By Senator Block—An act to add Sections 22602 and 22603 to the Financial Code, relating to finance lenders.

Senate Bill 198: By Senator Morrell (Principal coauthor: Assembly Member Obernolte)—An act to repeal Chapter 1.5 (commencing with Section 4210) of Part 2 of Division 4 of the Public Resources Code, relating to fire prevention.



Senate Bill 199: By Senator Hall (Principal coauthor: Senator Beall) (Coauthors: Assembly Members Bonilla, Lackey, Rodriguez, and Waldron)—An act to amend Section 12300 of the Welfare and Institutions Code, relating to public social services.

Senate Bill 200: By Senator Lara (Principal coauthor: Assembly Member Bonilla)—An act to amend Section 48204 of the Education Code, relating to pupils.

Senate Bill 201: By Senator Wieckowski—An act to add Section 6254.50 to the Government Code, relating to public records.

Senate Bill 202: By Senator Hernandez—An act relating to controlled substances.
