### INTRODUCTION AND FIRST READING OF SENATE MEASURES

The following measures were introduced, read the first time and transmitted to the Committee on Rules for assignment:

**Senate Bill 203:** By Senator Monning (Coauthors: Senators Leno, Mitchell, Pan, and Pavley) (Coauthors: Assembly Members Chiu, Williams, and Wood)—An act to add Article 15 (commencing with Section 111224) to Chapter 5 of Part 5 of Division 104 of the Health and Safety Code, relating to public health.

**Senate Bill 204:** By Senator Pavley—An act to amend Section 5080.16 of, and to add and repeal Section 5003.9 of, the Public Resources Code, relating to state parks.

**Senate Bill 205:** By Senator Beall—An act to amend Section 459.5 of the Penal Code, relating to crime.

**Senate Bill 206:** By Senator Gaines—An act to add Section 43003 to the Health and Safety Code, relating to vehicles.

**Senate Bill 207:** By Senator Wieckowski—An act to amend Section 39716 of the Health and Safety Code, relating to greenhouse gases.

**Senate Bill 208:** By Senator Lara—An act to add and repeal Chapter 7 (commencing with Section 10551) of Part 2.2 of Division 6 of the Water Code, relating to water.

**Senate Bill 209:** By Senator Pavley—An act to amend Section 2774 of the Public Resources Code, relating to surface mining.

**Senate Bill 210:** By Senator Galgiani—An act to amend Sections 42651, 42652, 42653, and 42654 of the Food and Agricultural Code, relating to fruit, nut, and vegetable standards.



**Senate Bill 211:** By Senator Hancock—An act to amend Section 47605 of the Education Code, relating to charter schools.

**Senate Bill 212:** By Senator Mendoza—An act to amend Section 11353.6 of the Health and Safety Code, relating to controlled substances.

**Senate Bill 213:** By Senator Block—An act to amend, repeal, and add Section 231 of the Code of Civil Procedure, relating to juries.
