Dear Secretary Alvarez: I am writing to explain my vote on Senate Bill 287 on Tuesday, May 26, 2015.

Senate Bill 287 was File Item 21 on Senate Third Reading on May 26, 2015. Senate Bill 287, as introduced, would require privately owned buildings with capacities of 200 persons or greater, that are not owned or operated by the state or any local government entity, and are constructed on or after January 1, 2016, to have an automated or automatic external defibrillator (AED) on the premises, as specified.

I was concerned about Senate Bill 287 exempting buildings owned or operated by the state or any local government entity from the requirement to have an AED on the premises, and planned on voting against the bill because of this exemption.

After the author made his floor statement, Senator Tom Berryhill asked the author about this exemption for state and local governments. The author answered by stating there was a memorandum issued by the Director of the Department of General Services (DGS) that mandated AEDs for all new state buildings. The author additionally stated that the memorandum goes a step further than Senate Bill 287 and requires AEDs to be put into all existing state buildings that fit this requirement, and that at the state level the bill is currently unnecessary. Senate Bill 287's author reiterated this point, stating that under the memorandum, all new state buildings that meet this requirement would have AEDs.

I accepted the author's explanation for the exemption, and on the basis that state and locally owned and operated buildings are required to have AEDs on their premises, voted Aye on Senate Bill 287.

However, I have since come to learn that the DGS Memorandum referenced by the author, Management Memorandum MM 07-03, dated February 6, 2007, with an expiration date of February 6, 2008, did not require AEDs in existing state buildings, nor did it require installation of AEDs in new state buildings. MM 07-03 simply states, "The use of AEDs may be implemented to the maximum extent possible in State-owned and leased buildings."

After I learned of this and explained my concerns to the author's staff about having incorrect information presented on the Floor of the Senate, and my intention to explain my vote with a letter to the Senate Journal, the author of SB 287 agreed to pull the bill.

Unfortunately, I was made aware last week that the author has decided to pursue passage of the bill in the Assembly. However, I was informed that the author amended the bill in the Assembly to add state buildings, which I appreciate.

Had I known state law and regulation does not require the installation of AEDs in new state buildings, I would have not voted Aye on Senate Bill 287 as passed off the Senate Floor on May 26, 2015.

If the bill comes back for Senate concurrence, I will cast my vote based on the new language. It is necessary that the Senate receives factual information from the authors presenting legislation on the Floor so that all Senators may make informed votes. I appreciate this opportunity to explain my initial AYE vote on SB 287.
