Dear Mr. Alvarez: I respectfully submit this Letter to the Journal to clarify the legislative intent of my Senate Bill 63, now in enrollment, concerning the proposed amendment of Harbors and Navigation Code Section 1698. This letter is necessary to clarify the intent, purpose and scope of this new language.

The amendment of Harbors and Navigation Code Section 1698 would add the term "or any capital improvement that improves environmental quality" to subparagraph (a)(6) of that section which under current law only includes "Remediation." The purpose of amending Section 1698 of the Harbors and Navigation Code is to include environmental quality projects which are not solely or technically remediation in and of themselves, but stand alone capital improvement projects in their own right in the definition of "Port or harbor infrastructure" but only so long as their "primary or predominate use is of direct benefit to the port or harbor" pursuant to subparagraph (a).

The amendment of Section 1698 is not intended to enlarge any rights or authorities of any state entity, or to otherwise alter existing trust obligations or the responsibilities of grantees, add any unauthorized or inconsistent uses, or otherwise enlarge the definition of this infrastructure. The

amendment of Section 1698 to add "environmental quality" projects is intended to enhance the principle purpose of Section 1698 which is to identify that infrastructure which has a "primary or predominant use [which] is of direct benefit to the port or harbor" but not in any other way, shape or manner authorize infrastructure which is not port or harbor related.

This amendment is added solely with the intent to add environmental quality projects to this definition because such projects already occur under the management and administration of these lands by the State and its grantees, which exercise management authority over state lands as an issue of statewide concern and, specifically, that this authority cannot be circumvented by, nor can any management structure for such lands be altered through, the local ballot-initiative process. With respect to its application to a Seaport Infrastructure Financing District, this amendment is only intended to make it explicit that Infrastructure Financing District revenues may be expended on environmental quality projects within a port or harbor.
