Dear Senator Fuller: I introduced SB 326 to continue to provide additional Medi-Cal reimbursement for air ambulance services through a nominal flat \$4 fee on traffic violations. Many of the instances where an air ambulance service is required involve a traffic accident; these traffic accidents are often caused by speeding or reckless driving. Air ambulance services are critical in these instances. A patient's life depends on their immediate transport from the scene of the accident to the emergency room.

Air ambulance providers do not choose which calls to take. They operate as a regional resource and are requested by the CHP or other EMS first responders only in the most critical cases. They cannot turn away a patient because they cannot pay. While some patients have adequate insurance to cover the air ambulance transport, others do not have any insurance or the service is underfunded by a government insurance program. SB 326 and its predecessor AB 2173 (2010) are intended to provide additional funding for Medi-Cal services, understanding the natural nexus between traffic accidents and traffic violations.

Amendments included in the bill by the Assembly contemplate the need for an alternative funding source for these additional Medi-Cal payments. The amendments in the bill require the Department of Health Care Services to develop a plan for an alternative funding source to the penalty assessment that will adequately reimburse these providers. It is not my intent to obligate the Department of Health Care Services or the General Fund to pay these rates going forward. My understanding is that the plan will be used to inform the legislature should it decide to discontinue the use of the penalty assessment.

Furthermore, it is my intent to clarify in the next legislative session that SB 326 will not obligate the general fund or the Department of Health Care Services to a specified reimbursement rate for air ambulance services. Next year's budget process can provide us an opportunity to address this issue. I will ask another independent entity rather than the Department to conduct the analysis of alternative funding options to address any concerns relating to the department's workload or funding obligations.

The goal of this bill is to continue the funding for two additional years, which is critical for the continuation of air ambulance services throughout California. Without the successful passage and signature of SB 326, air ambulance rates will revert to levels established over 20 years ago and cost the GF millions of dollars. This will jeopardize services and providers. I look forward to working on clarifying SB 326 and respectfully request this letter to be printed in the Senate Daily Journal.

Dear Mr. Alvarez: As the author of Senate Bill No. 13, I am requesting the inclusion into the Senate Daily Journal my statement to clarify the intent of the bill as it relates to water corporations regulated by the Public Utilities Commission (PUC).

SB 13, a bill that makes numerous technical and cleanup amendments to the Sustainable Groundwater Management Act (SGMA), includes an amendment that removes a major impediment to participation in the new SGMA institution, Groundwater Sustainability Agencies (GSAs). Previously, SGMA required local agency approval for public water systems that happen to be water corporations regulated by the PUC to participate fully in GSAs. SB 13's amended provision in Section 10723.6 (b) now enables PUC-regulated public water systems to participate in a GSA through a memorandum of agreement or other legal agreement without conferring undo powers to such a nongovernmental entity.

Section 10723.6 (b) achieves two important outcomes: (1) it properly precludes the ability of local agencies to deny membership and participation in a GSA by these regulated public water systems, and (2) ensures that when a regulated water supplier has the largest or one of the largest groundwater management operations in a basin or subbasin subject to SGMA's requirements, the GSA in question will have the benefit of that supplier's experience, management expertise and technical prowess.

Section 10723.6 (b) is intended to prevent local agencies from excluding PUC-regulated water corporations from an executive management role in a GSA, to give these regulated public water suppliers the authority necessary to fully participate in a GSA and to clarify that public agency approval is not necessary. Any GSA that includes a geographic area where water is provided by a water corporation regulated by the Public Utilities Commission, should include these water utilities as full participating members. Indeed, for many years, the Sacramento Groundwater Authority has successfully managed groundwater resources in the region through a

joint powers authority whose members have long included PUC-regulated water corporations.

In short, successful implementation of the Sustainable Groundwater Management Act will require coordination and collaboration by all groundwater pumpers in a basin regardless of their ownership or organizational structure.

Dear Mr. Alvarez: The Committee on Budget and Fiscal Review, which I chair, has authored Senate Bill 107 relating to redevelopment dissolution and local agencies. I submit this letter to the Senate Journal for the purpose of clarifying the intent of three aspects of this measure.

Section 34191.4 (d) of the Health and Safety Code relates to loans that have been approved by the Department of Finance. It is the intent of the Legislature that the measure shall not result in the denial of a loan that has been previously approved prior to the effective date of this bill. Additionally, it is the intent of the Legislature that this measure shall not impact the judgments, writs of mandate, and orders entered by the Sacramento Superior Court in the following lawsuits: (1) City of Watsonville v. California Department of Finance, et al. (Sac. Superior Ct. Case No. 34-2014-80001910); (2) City of Glendale v. California Department of Finance, et al. (Sac. Superior Ct. Case No. 34-2014-80001924).

Section 34191.4 (b) (2) (C) (ii) of the Health and Safety Code relates to repayments on loans for infrastructure purposes to a city, county, or city and county that created a former redevelopment agency. It is the intent of the Legislature that the total amount of each loan to be repaid shall not exceed \$5.0 million.

Section 34171 (d) (1) (F) (i) and (ii) of the Health and Safety Code relates to litigation costs paid out of the successor agency's administrative cost budget. It is the intent of the Legislature that these litigation costs shall not prohibit a nonprofit from collecting payment for attorney fees, should the nonprofit be successful in any litigation it brings against a successor agency.
