SIMONA AGNOLUCCI, has been appointed to the University of California, Hastings College of the Law Board of Directors. Agnolucci has been a partner at Kecker and Van Nest since 2015, where she was an associate from 2012 to 2015. She was an associate at Howard, Rice, Nemerovski, Canady, Falk and Rabkin from 2007 to 2012 and served as a law clerk for Judge William C. Canby, Jr. from 2006 to 2007. Agnolucci earned a Juris Doctor degree from the University of California, Hastings College of the Law. Appointed 12/03/2015. Effective 12/10/2015.

Member, University of California, Hastings College of the Law Board of Directors, vice, Carin T. Fujisaki, term expired. Term ending 12/10/2027.

GEOFF LONG, has been appointed to the California Commission on Peace Officer Standards and Training. Long served as policy director in the Office of Senate President pro Tempore Kevin de León from 2014 to November 2015 and was a chief consultant for the California State Assembly Appropriations Committee from 1995 to 2014. He was chief consultant for the California State Assembly Committee on Budget from 1993 to 1994 and held several positions for the California State Assembly Ways and Means Committee from 1984 to 1993, including chief consultant, principal consultant, and senior consultant. Long served as a field representative in the Office of California State Senator Al Alquist from 1983 to 1984. He was a reporter at the Grand Forks Herald from 1982 to 1983 and a teacher at Bellarmine College Preparatory from 1979 to 1982. Long earned a Master of Arts degree in religious studies from St. John's University. Appointed 12/17/2015. Effective 12/21/2015.

Member, California Commission on Peace Officer Standards and Training, vice, Bernard Melekian, resigned, unknown. Term ending 09/18/2016.



MICHAEL “DANA” GIOIA, has been appointed as California Poet Laureate. He has been the Judge Widney professor of poetry and public culture at the University of Southern California since 2011. As chairman of the National Endowment for the Arts from 2003 to 2009, Gioia launched several nationwide programs to expand public support for the arts and for arts education, with a focus on fostering youth creativity and expression. These initiatives include the Poetry Out Loud contest for high school students, the Big Read program to promote community reading initiatives across the country, and Operation Homecoming: Writing the Wartime Experience, a project to support returning troops and their families. In 2003, Gioia compiled the anthology *California Poetry: From the Gold Rush to the Present* as part of the California Legacy Project. His 1991 volume *Can Poetry Matter?* was a finalist for the National Book Critics Circle award. Gioia is also winner of the 2002 American Book Award and was honored with the Presidential Citizens Medal in 2008 for his public service in support of the arts. Gioia earned a Master of Business Administration degree from Stanford University, a Master of Arts degree in comparative literature from Harvard University, and a Bachelor of Arts degree from Stanford University. Appointed 12/03/2015. Effective 12/09/2015.

California Poet Laureate, vice, Juan F. Herrera, term expired. Term ending 2 years from 2nd Commission.

MARYSOL DE LA TORRE-ESCOBEDO, has been appointed to the California Commission on Teacher Credentialing. De la Torre-Escobedo has been a teacher for the Chico Unified School District since 2007. She earned a Master of Arts degree in education and teaching from Stanford University. Appointed 12/01/2015. Effective 12/18/2015.
