SUSANNE "LYNN" SADLER, has been appointed deputy director of the Division of Boating and Waterways at the California Department of Parks and Recreation. Sadler has been director of the California Public Utilities Commission, Office of Governmental Affairs since 2012. She was assistant public advisor for the California Energy Commission from 2010 to 2012, president and chief executive officer at the Mountain Lion Foundation from 1996 to 2010, and natural resources director at the Planning and Conservation League from 1989 to 1996. Sadler was a legislative consultant for the California State Senate Joint Committee on Science and Technology from 1986 to 1987, assistant director for information and policy coordination at the California Department of Personnel Administration from 1981 to 1982, and a staff member in the Office of Governor Edmund G. Brown Jr. from 1980 to 1981. Appointed 11/25/2015. Effective 01/04/2016.

Deputy Director, Division of Boating and Waterways, California Department of Parks and Recreation, vice, Sylvia Ortega Hunter, withdrawn from the Senate, 06/10/2014. Term ending at the pleasure of the Governor.

SCOTT M. KERNAN, has been appointed as Secretary for the California Department of Corrections and Rehabilitation. Kernan has served as undersecretary for operations at the California Department of Corrections and Rehabilitation since March 2015. He was owner at Kernan Consulting from 2011 to 2015. Kernan served as undersecretary for operations at the California Department of Corrections and Rehabilitation from 2008 to 2011, where he was chief deputy secretary of adult operations from 2007 to 2008 and deputy director of adult institutions from 2006 to 2007. He served as warden at California State Prison, Sacramento from 2004 to 2006 and warden at Mule Creek State Prison from 2003 to 2004, where he served as a chief deputy warden from 2001 to 2003 and as a correctional administrator from 2000 to 2001. Kernan served as a correctional captain at the California Department of Corrections and Rehabilitation from 1991 to 2000, where he was a correctional lieutenant from 1987 to 1991, an associate budget analyst from 1986 to 1987, a correctional sergeant from 1985 to 1986, and a correctional officer from 1983 to 1985. He served in the U.S. Navy from 1979 to 1982. Appointed 12/28/2015. Effective 01/04/2016.

Secretary, California Department of Corrections and Rehabilitation, vice, Jeffrey Beard, resigned 01/01/2016. Term ending at the pleasure of the Governor.

KEVIN R. CHAPPELL, has been appointed to the Board of Parole Hearings. Chappell has been a correctional administrator retired annuitant at California Correctional Health Care Services since 2015. He served as warden at San Quentin State Prison from 2012 to 2014, and held several positions at Folsom State Prison from 2010 to 2012, including chief deputy warden and associate warden. Chappell was chief of the Classification Services Unit at the California Department of Corrections and Rehabilitation from 2009 to 2010, where he was facility captain from 2006 to 2008 and a correctional administrator in the Division of Adult Institutions from 2008 to 2009. He was a lieutenant at the Richard A. McGee Correctional Training Center from 2004 to 2006, served in several positions at the California Medical Facility, Vacaville from 1995 to 2004, including lieutenant, counselor, and sergeant, and was a correctional officer at Folsom State Prison from 1987 to 1995. Appointed 12/31/2015. Effective 01/04/2016.
