Dear Mr. Alvarez: Senate Bill 1266 is intended to create a formal communication process under state law between Joint Powers Authorities (JPAs) formed for the local performance of governmental functions that includes the provision of municipal services, and Local Agency Formation Commissions (LAFCOs). This legislation is intended merely to require such JPAs to provide copies of the agreement evidencing their establishment, or amendments thereto, to their respective LAFCO, just as they are currently required to do with the Secretary of State.

The requirement to file a copy of the agreement and any amendments to the agreement with the LAFCO in each affected county as specified in SB 1266 shall not apply to any JPA that is an agency or entity constituted pursuant to a joint powers agreement exercising the authority and powers provided pursuant to Government Code Section 990.8 and/or Labor Code Section 3700(c), related to risk management, group insurance and debt-financing services.

Accordingly, JPAs exercising the authority and powers provided pursuant to Government Code Section 990.8 and/or Labor Code Section 3700(c) have been omitted from the proposal. It is not my intent to cover all JPAs, as certain JPAs do not substantively influence the delivery of local municipal services.
