Senator Allen asked for, and was granted, unanimous consent that the following letter be printed in the journal:

August 29, 2016

*Mr. Daniel Alvarez*

*Secretary of the Senate*

Dear Mr. Alvarez: I submit this letter to the Senate Daily Journal to clarify legislative intent of one of my bills, Senate Bill 778, relating to automotive repair.

Specifically, language was provided to Legislative Counsel that said “For the purposes of section 9880.1, services provided by Automotive Maintenance Providers shall be considered as minor services.” That language was revised to define “Minor services” as those services provided by an automotive maintenance provider. While this language is similar, it does not correctly encompass the intent of the proposed language. There was not time within the Legislative Calendar to submit further amendments to change this paragraph.

This letter clarifies that it was my intent that the language provide a statutory exemption for Automotive Maintenance Providers from being later defined by regulation as an Automotive Repair Dealer. It was not my intent that the definition of minor services be limited to the services provided by Automotive Maintenance Providers. The legislative overlap between “Automotive Maintenance Providers” and “minor services” is meant to create a baseline set of “minor services” to which rulemaking directed by SB 778 may add to. This ensures the integrity of the new Automotive Maintenance Provider category, while giving the Director of the Department of Consumer Affairs latitude to determine whether remaining, non-statutorily excluded activities will be regulated as repair or exempted “minor services.”



Therefore, baseline “minor services” are the Automotive Maintenance Provider category of services associated with fluid and filter changes, fluid treatments like fuel treatment services and high mileage oil supplementation, and belt and windshield wiper blade replacement.

Dear Mr. Alvarez: I have authored Senate Bill 887 to provide statutory direction to the reform of gas storage well regulation and oversight by the state in order to help ensure in the future that no other community has to undergo the disruption and upheaval that my constituents living near the Aliso Canyon gas storage facility recently experienced. I am submitting this letter to the Senate Journal to provide clarity to the intent of Senate Bill 887.

Senate Bill 887 adds a new article to the Public Resources Code specific to natural gas storage wells. Within the article, gas storage wells are specifically defined ("gas storage well" means an active or idle well used primarily to inject natural gas into or withdraw natural gas from an underground natural gas storage facility). This structure and definition recognizes that gas storage wells are not oil and gas production and/or injection wells, although gas may be present in all of these well types. Senate Bill 887 does not apply to oil and gas production wells, injection wells, gas disposal wells and pressure maintenance wells.

*To the Members of the California State Senate:*

I am returning **Senate Bill 1257** without my signature.

This bill requires an applicant for membership in the State Bar to complete at least fifty hours of supervised pro bono legal service. It also requires that a practicing lawyer or law professor supervise the student.

I certainly support law students and lawyers providing pro bono legal services. Some law schools already promote volunteerism and pro bono service in various ways and many employers also require a certain amount of pro bono hours for associates and clerks. While I commend the author for his desire to further these efforts, I don't believe a state mandate can be justified.

Law students in California are now contending with skyrocketing costs—often more than \$200,000 for tuition and room and board—and many struggle to find employment once they are admitted to the Bar. In this context, I believe it would be unfair to burden students with the requirements set forth in this bill.



Instead, we should focus on lowering the cost of legal education and devising alternative and less expensive ways to qualify for the Bar Exam. By doing so, we could actually expand the opportunity to serve the public interest.
