Dear Mr. Alvarez: SB 1160 would enact several significant reforms that are intended to improve California's workers' compensation system for all stakeholders. One of the key reforms is found in Section 8 of the bill, which would amend Labor Code §4903.05 by adding a new requirement that lien filers include a declaration under penalty of perjury where they state their eligibility to file a lien. Under existing law, the ability of a workers' compensation stakeholder to file a lien is provided by Labor Code §4903, and SB 1160 does not alter, amend, or change Labor Code §4903. It is not my intent to in any way abridge or alter the existing ability of lien claimants to file lawful and legitimate liens in California's workers' compensation system.

Specifically, some stakeholders have pointed to a perceived difference between the wording of Labor Code §4600 and Labor Code §4903.05(c)(1)(E), arguing that the term "unreasonably refused" deviates from Labor Code §4600. Labor Code §4903.05(c)(1)(E) simply repeats Labor Code §4600 in the negative. The difference between "refused unreasonably" or "unreasonably refused" is a semantic one, and it is my intent that the term "unreasonably refused" does not deviate from Labor Code §4600.



Additionally, some stakeholders have raised the concern that interpreters who interpret languages where a certification is not currently available will be barred from filing a workers' compensation lien. Under existing law, these interpreters are able to file liens, and SB 1160 will not impact that. Labor Code §4903.05(c)(1)(G) contains broad authority for the administrative director of the Division of Workers' Compensation to create a disclosure that fully captures the lawful liens allowed under Labor Code §4903. It is my intent that this disclosure continues to allow interpreters to file liens where a certification is not available for the language they interpret.

Dear Senators De León and Fuller: This letter serves to clarify the intent of SB 661 (Hill), which would enact the Dig Safe Act of 2016, a bill intended to improve safety in the excavation around subsurface installations.

The bill creates a new type of excavation “ticket” that allows a person to request an annual ticket for areas where the business of the property is excavation, such as is the case on land used for agricultural purposes and flood control facilities. Paragraph (1) of subdivision (c) of the new Section 4216.10 requires an onsite meeting between the subsurface installation operator and the excavator when the area contains or is within 10 feet of a high priority subsurface installation, and paragraph (2) of subdivision (c) allows either party to request an onsite meeting when the area contains or is within 10 feet of any other type of subsurface installation. In the case of a high priority subsurface installation, the bill directs the operator and excavator to “develop a mutually agreed upon plan for the area of continual excavation.”

The intent of the onsite meeting described in subdivision (c) of Section 4216.10 is to create a discussion and common understanding of how to safely work in the vicinity of the subsurface installation. An area of continual excavation may, however, include land very far from a subsurface installation. There is no intent that the plan developed pursuant to subdivision (c) include information about excavation activities that are not in the vicinity of the subsurface installation, nor is there intent that an operator have any opportunity to provide input into an excavator’s decisions about what activities to undertake in the area of continual excavation *except* when those activities are in the vicinity of the subsurface installation.
