Assembly Bill 18—An act to add Chapter 33 (commencing with Section 7599) to Division 7 of Title 1 of the Government Code, and to amend Sections 6051.7, 6201.7, 10752, 10752.1, 17041, 17054, and 17062 of, and to add Sections 7101.4, 10752.2, and 11001.6 to, the Revenue and Taxation Code, relating to local government finance, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.
