Senate Bill 24: By Senator Wright (Principal coauthor: Senator Lowenthal) (Principal coauthor: Assembly Member V. Manuel Pérez) (Coauthors: Senators Huff and Lieu) (Coauthors: Assembly Members Alejo, Davis, Galgiani, Mendoza, Portantino, Solorio, and Swanson)—An act to amend Section 42238 of the Education Code, and to add Sections 33334.30, 33334.31, 33607.6, and 33607.65 to the Health and Safety Code, relating to redevelopment, and declaring the urgency thereof, to take effect immediately.
