Code, and to amend Sections 384 and 399.8 of the Public Utilities Code, relating to energy, and making an appropriation therefor.

**Senate Bill 29:** By Senators Steinberg and Pavley—An act to add Article 3 (commencing with Section 25620.20) to Chapter 7.1 of Division 15 of the Public Resources Code, relating to energy.
